## NOTIFICATION OF EXTENSION OF CLOSURE

In furtherance to our endorsement number DR/GA/CE/2020/special/819 to 918 dated 3<sup>rd</sup> May 2020 whereby extension of closure of Maharshi Dayanand University and Colleges under its jurisdiction up to 17-05-2020 was notified in view of the decisions of Central Government and State Government mentioned previously and therein, it is informed that the authorities have decided to extend the closure with some controlled functioning up to 31<sup>st</sup> May 2020 in compliance with the directions issued by the Ministry of Home Affairs, Government of India bearing no. 40-3/2020-DM-1(A) dated 17-5-2020 and the communication made by the Chief Secretary to Haryana Government vide no. 62/19/2020-6GS1 dated 18-5-2020 and by the Principal Secretary to Govt. of Haryana, Higher Education Dept vide no. KW 18/79-2020 UNP (4) dated 19-5-20. Steps/measures being taken/adopted by the University in light of the University's earlier notifications dated 13-03-2020 and 23-03-2020 and others issued from time to time over the relevant issues will remain actively in force during this tenure and for the times to come.

All the offices/departments in the University shall perform controlled functioning with 100% attendance of Groups A and B that while other personnel shall attend with 50% manpower as per roster to be prepared for odd and even dates by the controlling officers under intimation to the Registrar. However, controlling officers may order any official to attend duties beyond roster as per need and may summon 100% personnel upon availability of sufficient space for ensuring social distance, excepting officials from containment zone, if any. All officials performing essential duties shall attend to their work in 100% strength. All will maintain social distancing as per protocol and will strictly follow the national directives for COVID-19 management. The classroom teaching and public dealing shall remain restricted during this period.
