- 1. Confirmed the minutes of the previous meeting of the Faculty of Performing & Visual Arts held on 05.04.2019 (already circulated) (Annexure-I pages- 1 and 2).
- 2. To consider the recommendations of PG BOS in Music made vide Reso. No. 3 of its meeting held on 16.06.2019 that the amendments in eligibility condition for admission to M.A Music (Vocal & Instrumental-Sitar) from the session 2021-22 may be made as under:

The Faculty considered the above eligibility conditions for admission to M.A Music (Vocal & Instrumental-Sitar) and recommended with some deletions in eligibility conditions i.e minimum two years experience as Music teacher (after graduation in any discipline) in any recognized school for admission to M.A Music (Vocal & Instrumental-Sitar) from the session 2021-22.

3. To consider the recommendations of PG BOS in Music made vide Reso. No. 4 of its meeting held on 16.06.2019 that the M.Phil (Music) Programme may be discontinued from the session 2020-21 as more than 60% seats in M.Phil (Vocal & Instrumental) remained vacant for the last four years.

The Faculty considered the above recommendations of PG BOS and recommended that the M.Phil (Music) Programme will be discontinued from the session 2020-21.

4. To consider the recommendations of the P.G. Board of Studies in Visual Arts made vide Reso. No. 1 and 3 of its meeting held on 07.12.2019 that the following courses be introduced in S.F.S Mode from the session 2021-22 in place of M.F.A (6 year integrated course, regular mode) in the Department of Visual Arts:-

- (ii) Sanction intake alongwith fee structure of the above courses and requirements of staff may also be prescribed as per Annexure-II Pages-1-5.
- (iii) The Syllabus and Scheme of Examinations of B.F.A (4 year) and M.F.A (2 year) programs may be prescribed from the session 2021-22 as per Annexure-III pages-1 to 127.

The Faculty considered the above recommendations of PG BOS in Visual Arts and recommended that the M.F.A (6-year integrated Program, regular mode) in the Department of Visual Arts will remain continue as such. Further, starting of B.F.A (4 year) and M.F.A (2 year) Programs in S.F.S mode, with sanction intake alongwith fee structure and requirement of staff as recommended by PG BOS be approved. Further resolved that HOD (Visual Arts) will prepare the scheme and syllabi for the incoming Programs.

- 5. To consider the recommendations of the P.G Board of Studies in Music made vide Reso. No. 1 of its meeting held on 24.08.2020 that the syllabi, sanction intake alongwith fee structure, eligibility criteria admission procedure of One Year Diploma in Tabla and One Year Diploma in Harmonium may be approved from the session 2020-21 (Annexure- IV pages- 128 to 153).
  - The Faculty considered the recommendations of PG BOS in Music and approved the syllabi of Diploma Programs and scheme of examinations recommended to Academic Council (fee structure, starting of Programs, sanction intake, eligibility conditions of these Programs already approved by the Vice-Chancellor).
- 6. To consider the recommendations of the P.G Board of Studies in Music made vide Reso. No. 2 of its meeting held on 24.08.2020 that the Project work/field work may be introduced in M.A (Music) 4<sup>th</sup> Semester and the Scheme of Examination of M.A 4<sup>th</sup> semester may be revised from the session 2020-21 (Annexure- V pages- 154 to 157).
