Sir/Madam,

I am directed to inform you that the Vice – Chancellor has allowed to make admission in MBA and MCA Program being run by your Colleges, both new admission as well as that of intermediate semesters i.e. 3rd, 5th, 7th and 9th Semester (as the case may be) up to 30.09.2020 with the following conditions by the Colleges at their own level, strictly complying with the University rules and regulations:-

1. Online Admissions may be made by the Colleges strictly as per merit and eligibility conditions prescribed by the University. Reservation Policy of the State Government may be followed.
2. Arrangements may be made by the colleges at its own level for collecting the fee from the candidates.
3. Online classes may be conducted by the colleges OR as per instructions, be received from the State Govt. in the matter.

Eligibility conditions for admission to various courses and Admission Procedure & Regulations have already been sent which are also available on the University website.

It will be the entire responsibility of the Principal/Director of the concerned College/Institute to ensure that no wrong admission is made by the College/Institute.

It is further made clear that wrong admission(s), if any, made by the College/Institute shall not be accepted/regularized by the University and the expenditure incurred on litigation in such cases by the University shall be borne by the Principal/Director of the College/Institute concerned.
