MINUTES OF THE MEETING OF THE COMMITTEE TO CONSIDER AND DECIDE VARIOUS ISSUES PERTAINING TO ADMISSION OF FOREIGN NATIONALS IN MAHARSHI DAYANAND UNIVERSITY, ROHTAK HELD ON 26.09.2020 AT 11:00 AM IN THE COMMITTEE ROOM ADJACENT TO REGISTRAR'S OFFICE.

The committee deliberated the issue of seats for foreign students in the programs regulated by regulatory bodies, had detailed deliberations on it and decided to recommend the following:

1. Admission of Foreign Nationals in UGC regulated programs.

The provision already exists in the Prospectus 2020-21 for Admission to programs offered by University Teaching Departments at page no. 28, which is reproduced as under:

"There is provision of having 15% additional supernumerary seats for foreign candidates, out of which 1/3rd seats have been earmarked for the children of Indian workers in the Gulf countries and Southeast Asia. These seats will not be filled, if such foreign candidates are not available."

2. Admission of foreign nationals in programs regulated by apex bodies like BCI, PCI, AICTE/NCTE.

- i. As far as creation of seats for Foreign Nationals within "approved intake" is concerned, it may be allowed only if seats remain vacant after the last round of the admission. The relevant rule of AICTE is reproduced as under:

"Beside this, any vacant seat in the "Approved Intake" after the last round of the admission of the concerned State Government/ UT, may be filled with NRI/ Foreign Nationals/ Overseas Citizen of India (OCI)/ Persons of Indian Origin (PIO)/ Children of Indian Approval Process Handbook 2020-21 50 Workers in the Gulf Countries, subject to the approval from AICTE for the above seats and fulfilment of requisite norms as specified in the Approval Process Handbook."

- ii. Fifteen percent (15%) supernumerary seats over and above the "Approved Intake" per Course shall be approved in AICTE approved Institutions and University Departments, for admitting students from Foreign Nationals/ Overseas Citizen of India (OCI)/ Persons of Indian Origin (PIO)/ Children of Indian Workers in the Gulf Countries. One third (1/3) of these 15% seats shall be reserved for the Children of Indian Workers in the Gulf Countries.

The committee also observed that the seats for foreign students within the sanctioned intake for Indian students have been got approved by CIAA from the Competent Authority for the programs which are not mentioned in the Prospectus 2020-21, for foreign students. The committee recommends

that in the present cases, the seats be filled up in accordance with the provisions mentioned at 2(i) & 2(ii) above and with the prior approval of the concerned regulatory body.

Further resolved that admissions to the programs regulated by apex bodies be made for the academic session 2020-21 only after receiving approval of regulatory bodies i.e. BCI, PCI, AICTE/NCTE, whichever applicable. Meanwhile, the departments may initiate the process of seeking permission of the above said regulatory bodies.

The Committee also recommends that in all admissions related matters, CIAA should hold consultation with the concerned departments and thereafter the proposal be placed before the Admission Committee for consideration. All this should precede the preparation of the prospectus.
