I am directed to inform you that as per fee structure approved by the Executive Council vide Resolution No.52 in its meeting held on 4.9.2019, the last date for submission of application alongwith prescribed fee on the payment of 100% extra charges for opening of new College/Institute/increase in seats/additional course(s) in (Govt./Govt.Aided/SFS) College for grant of Provisional Affiliation for the current academic session 2021-22 was 30.04.2021.

No request received in the University after **30.09.2021** will be entertained for the current academic session 2021-22.
