Sub: - Admissions in Girls Hostels for the session 2020-21 for the purpose of Theory Examinations only.

Sir/Madam,

It is to bring to your kind notice that the hostel accommodation will be provided (from 01.03.2021) to the students of UTDs with the following conditions:-

- a) All Old residents whose examinations are expected to commence from 03.03.2021, may be allowed admission to hostels only for the purpose of theory examinations. They will have to vacate the hostels as soon as the examinations are over.
- b) The scholar should submit **RT-PCR** (**COVID-19**) **negative** test report conducted within 72 hour before the admissions to the hostels.
- c) If a resident after taking admission stays away from the hostel more than three days, He/She will have to submit RT-PCR (COVID-19) negative test report again, conducted within 72 hour before re-entering the hostel.
- d) The Hostel admission form should be forwarded by the concerned Head/Director of the Department/Institute/Centre along with No Objection certificate from the parents.
- e) The hostel accommodation shall be provided only to the students who will appear offline in the intermediate exams to be held in March 2021.
- f) The reservation criteria as per Haryana Government guidelines need to be followed.
- g) Students expelled during the past from M.D.U Hostels are not eligible to apply.
