Gurgaon: Several parents of students studying at various private schools in the city on Tuesday staged a protest outside the main secretariat demanding their direct involvement in the school fee structure. They also demanded that the government should provide uniformity in the fee structure across all private schools in the city.

The protest was held outside the main secretariat and parents submitted a memorandum to the city magistrate. They also accused the district authority of not implementing the state government's order regarding the fee structure.

Another parent, Dhruv Bansal, said, "If the schools do not implement the order and the matter is not resolved by the district authority soon, we will call for a hunger strike." He also mentioned that the schools are charging fees under various heads, which is not fair to the parents.
