# 46. Amendment in the Ordinance of Ph.D. with regard to Co-Supervisor for Ph.D. Program in other University

Considered the action taken by the Vice-Chancellor in anticipation approval of Academic Council/Executive Council in approving the following and the amendment in the Ordinance of Ph.D. form the session 2020-21 be also made accordingly:-

The faculty of this University who wants to become Co-Supervisor for Ph.D. Program in other University, the following conditions shall be applicable as under:-

- 1. NOC from the M.D.University.
- 2. The half seat will be counted for each such supervision.
- 3. The number of seats including the seat offered as Co-Supervisor should not exceed the total permissible intake as prescribed in the Ordinance.
- 4. A teacher cannot be Co-Supervisor of more than four candidates at a time including the outside Co-Supervisor.
