Suspecting murder of youth's kin blo Shahzadpur r

Family members of Anil Kumar (23), whose body was found in a jungle under mysterious circumstances yesterday, blocked the Ambala-Shahzadpur road for about two hours today. They were demanding the arrest of all six persons booked for Anil's murder. The family members of Anil Kumar, a resident of Dhanan village in Shahzadpur, suspected foul play and the Ambala police registered a case against six persons. Anil's father Ashok Kumar in his police complaint stated that his son worked at a hospital in Panchkula. He didn't return home from the hospital on March 14 and instead informed them that he would come the next day. He didn't come on March 15 as well. His mobile phone was switched off and when the worried family contacted his colleagues, they were informed that Anil left the hospital after duty on his friend Mahipal's motorcycle on March 14. Ashok said Anil's body was recovered from the jungle on March 16 and a motorcycle was found parked nearby. The body bore injury marks
