(7)In case of any student getting positive of Covid-19 shall be provided another chance in offline mode only on some another convenient date in future. This shall, however, be subject to production of a valid RTPCR report issued by the Govt./Civil Hospitals only. The test report must be submitted by the student concerned in the Office of Controller of Examinations well before the date of concerned examination otherwise the same shall not be considered.
