The Committee deliberated upon the matter of re-opening of the University and recommended as under:-

1. The online classes shall continue to be conducted till further orders. The matter pertaining to holding of classes as well as opening of hostels in physical mode will be decided in accordance with the decision of the State Govt.
2. In the mean time, the hostels should be made ready for allotment to the students whenever allowed by the State Govt.
3. There shall be continuous focus on the five-fold strategy for effective management of COVID-19 i.e Test-Trace-Track-Vaccination and adherence of COVID-19 appropriate behavior when the classes are held in physical mode. To comply with the five-fold strategy, partial/complete vaccination be made mandatory for students, staff members and teachers of the University and the individual status should be uploaded on the university portal regarding vaccination.
4. No Masks - No Service shall be strictly observed in all the Departments/ Institutes/Offices of the University.
