Apart from imparting skill, MSME Technology Centre, Rohtak would be inculcating the entrepreneurial skills into a common person, providing them with the needed knowledge, developing the technical, financial, marketing and managerial skills and building the entrepreneurial attitude. Apart from this MSME Technology Centre, Rohtak would provide support to MSME in the catchment area.

OBJECTIVE:

The objective of this MOU is to express the willingness of both parties to engage in an effort to promote the competitiveness of MSME Technology Centre, Rohtak as well as its activities to develop and expand relationships with Maharshi Dayanand University, Rohtak.

SCOPE:

The scope of empowering the MoU is to impart knowledge/skills to the students of Maharshi Dayanand University (Main Campus), Centre for Professional & Allied Studies, Gurugram. MSME Technology Centre, Rohtak will also provide assistance to these above trained students for employment in the industries.

The faculty members of all these institutions can have the profit of training from MSME Technology Centre, Rohtak for their **Skill Development and Technological up gradation.**

MAHARSHI DAYANAND UNIVERSITY, ROHTAK & MSME TECHNOLOGY CENTRE, ROHTAK will have this MoU that will stand valid for following items.

- The students studying at Maharshi Dayanand University, Rohtak (Main Campus), Centre for Professional & Allied Studies, Gurugram and the faculty members of all these institutions can have the profit of training from MSME Technology Centre, Rohtak.
- MSME Technology Centre , Rohtak would organize Short Term Courses and Medium Term Courses(National Skill Qualification Framework complied/exempted) at MSME Technology Centre , Rohtak campus , which students can avail during vacations and internships (which would be as per fee prescribed by Ministry of MSME, Governing Counsel).
- MSME Technology Centre, Rohtak would exchange information of data on training, skills requirement and their relationship to emerging industrial needs.

- Both the institutions shall work together in matters relating to Training and Education relevant to changing technological needs in the areas of Design, Development, Implementation, review of the Curriculum and the updation of Resource Material.
- There will be exchange of faculty between both the institutions to impart the quality skills and training for betterment of the students of this region. Both the institutions will consider the visiting faculty at par with their own faculty.
- MSME Technology Centre, Rohtak would plan to continue the updation of education programs to keep the practicing engineers and faculty, abreast of development, in their respective field.
- MSME Technology Centre, Rohtak would organize joint workshops, seminars in the field of Technical Education and Industrial Training, to promote innovation, optimization of resources, penetration in frontier areas of emerging Technologies, Entrepreneurship and allied issues of mutual interest.
- MSME Technology Centre, Rohtak would organize visits of students and faculty of Maharshi Dayanand University, Rohtak (Main Campus), Centre for Professional & Allied Studies, Gurugram and Engineers & Managers of MSME Technology Centre, Rohtak to Maharshi Dayanand University, Rohtak (Main Campus), Centre for Professional & Allied Studies, Gurugram so as to increase interaction between the institutions.
- MSME Technology Centre, Rohtak would undertake joint projects to solve specific industrial problems that come up in due course of time.
- Both the institutions shall work together for development of Rural Areas/Villages in the catchment area.
- Both the institutions shall jointly hold Career Counseling Workshops for students of Maharshi Dayanand University, Rohtak (Main Campus), Centre for Professional & Allied Studies, Gurugram and colleges affiliated to Maharshi Dayanand University, Rohtak & MSME Technology Centre, Rohtak.
- Both the institutions shall set up a Collaborative Working Group which would provide direction to these interactive efforts between Maharshi Dayanand University, Rohtak and MSME Technology Centre, Rohtak.

FUNDING FOR SKILL DEVELOPMENT TRAINING PROGRAMMES

1) Self Financing Pattern

- All the courses will be run on self-financing basis and by collecting fees from the trainees/students.

MSME Technology Centre, Rohtak will provide discount of 20% on the prescribed fees with the Min. Batch of 20 students in which SC/ST students will be provided training free of cost. The Batch will be in the ratio as follows: All Categories except SC/ST :SC/ST, 78%:22%.

- The students joining any Skill training programmes at MSME Technology Centre, Rohtak will be considered as students of MSME Technology Centre, Rohtak for the duration of the program they will join. Certificates will be provided by MSME Technology Centre, Rohtak on successful completion of certificate programs. Minimum attendance of 80% is compulsory as per MSME norms for all the trainees.
- Paid as well as Free Webinar's / Seminar's / Touch-up programs shall be organized for the students of Maharshi Dayanand University, Rohtak (Main Campus), Centre for Professional & Allied Studies, Gurugram and colleges affiliated to Maharshi Dayanand University, Rohtak at MSME Technology Centre, Rohtak.

2) Sponsored Training Programmes

- MSME Technology Centre, Rohtak would regularly share information about different Government Schemes regarding free training for students/faculty with Maharshi Dayanand University, Rohtak.

(3) Validity

- This agreement will initially be for a period of 5 year from the date of signing either of the party can terminate the agreement with 90 day notice. Further extension of another period of five years may be decided on mutual consent.

(4) Arbitration (Dispute Resolution Mechanism)

- In Case of any dispute between the contracting parties, it would be amicably settled by mutual discussions. In case of any dispute remaining unresolved it would be referred to the Arbitrator appointed by the Vice Chancellor of Maharshi Dayanand University, Rohtak with the mutual consent of both the parties. The venue of the Arbitration proceeding shall be at Rohtak and language of Arbitration shall be in English. The Arbitration proceeding shall be conducted in terms of Arbitration & Conciliation Act, 1996 or any statutory modification of re-enactment thereof and. The expenses of the Arbitration proceeding shall be borne equally by the Parties or as may be decided by the Arbitrator.

(5) Governing Law

- This MoU shall be governed by any construed in accordance with the laws of India without regard to its conflict of laws provision.
- This MoU has been executed in two originals, one of which has been retained by Maharshi Dayanand University, Rohtak and the other by MSME Technology Centre, Rohtak, and each copy being an official version of the agreement and having equal legal validity. In witness where off, the parties have executed this MoU and represent that they approve, accept and agree to term contained herein.
