

MINUTES OF THE MEETING OF THE COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 01.04.2022 AT 11:00 A.M IN THE OFFICE OF THE DEAN ACADEMIC AFFAIRS FOR RECONSIDERATION OF RULES / CRITERIA FOR AWARD OF GOLD MEDALS.

Following were present:

- 2 Dean, Faculty of Management Sciences and Commerce
3. Head, Department of Computer Sciences & Applications
- 4 Controller of Examinations

The earlier recommendations of the Committee in its meeting held on 11.03.2022 were as under:

1. The students who have passed a program from this University with Gap Year between the Course, may not be considered for Award of Gold Medal.
2. The students, who have passed a program with Grace Marks from this University, may not be considered for Award of Gold Medal.
3. The students, who have passed a Program with Lateral Entry such as MCA, B.Tech, B.Pharmacy. etc, may not be considered for Award of Gold Medal.
4. The students who have submitted Project Work/Project Report/Dissertation etc. with late fee in the courses such as LL.B., LL.M. B. Pharmacy., M. Pharmacy, BBA, BCA, MCA etc. wherever prescribed in the Scheme of Examinations/Ordinances, may not be considered for Award of Gold Medal in the Convocation likely to be held in the month of April, 2022.
5. The Committee further recommended that the rules for Award of Gold Medals needs to be revisited and thus, proposed that a high level Committee comprising the following may be constituted by the Vice-Chancellor to frame new Ordinance/Rules for Award of Gold Medals :


- (a) Dean Academic Affairs - Convener
- (b) All the Deans of the Faculties
- (c) Controller of Examinations


The Committee further recommended that the recommendations as mentioned at point number 1 to 3 above may be made applicable on the students who have passed the program after the holding of last convocation by this University i.e. February 2018.


Now, upon receipt of request from a candidate namely Ms. Tanishka through the Head, Department of Pharmaceutical Sciences and Controller of Examinations for reconsidering the rules/criteria for award of Gold Medals recommended by the Committee in its earlier meeting held on 11.03.2022, the Committee again deliberated upon the issue referred at sr. no. 1 to 3 above, in its meeting held on 01.04.2022 and recommends as under:-

Since number of students during the last four years might have taken the certificates of merit being topper from the University and may have availed benefits, therefore the committee recommends that the aforementioned recommendations at point no. 1 to 3 above may not be made effective retrospectively and instead the same may be got applicable from July 2022 onwards so that any complications and litigation may also be avoided.
