Wheat bags found underweight in Rohtak grain market: Hafed

Says cost to be deducted from commission agent

Hafed, the government procurement agency, has found wheat bags to be underweight. These were procured at the Rohtak Grain Market this season at the minimum support price (MSP) of Rs 2,015 per quintal.

It has asked commission agents, engaged in the procurement process, to depositthe required wheat. It has also warned them that they would deduct the cost of wheat from their commission on failing to comply with the directives.

The commission agents fumed over the development and refused to deposit more wheat pleading that weight of the wheat might have gone down due to the drop in its moisture level as the produce remained lying at the grain market in the scorching heat several days after the procurement.

The wheat procured is weightd at the godown when it is brought from the grain market; Arhtivas are bound to to fill in for the loss, if any. Of the

total, 300-quintal wheat was less as per the procurement record hence the arhtiyas concerned have been asked to fill in for the loss at the earliest," said Pradeep Deswal, Manager at Hafed, Rohtak.

He maintained none of the arhtiyas had so far deposited the wheat despite being asked for the same thrice. "Now, we are planning to send their names to the headquarters so that the cost can be recovered by deducting it from their commission, which is 2.5 per cent per quintal," said Deswal, adding that a report in this regard will be sent to the headquarters by

the end of this week.

Mukesh Bansal, president New Grain Market Dealer Association, Rohtak, ha termed the action as unjusti fied stating that three govern ment agencies - Hafed Haryana State Warehouse Corporation and DFSC-had procured the wheat this sea son but only Hafed had detected the loss. "All bag do not have accurate amoun of produce, some have the produce in excess while some have lesser amount This time, Hafed is no counting the produce in excess but wanting arhtiya meet the loss." said Bansal.

HC: Can't rule out inherent rand deciding cut-off date for competi

The Punjab and Haryana High Court has made it clear that certain inherent randomness in determining the cutoff date for competitive examinations would always be

there. Else, it would give rise to unnecessary confusion.

The assertion came as Justice Arun Monga dismissed three pleas by 10 petitioners aspiring to be HCS officers. They were, among other things, seeking the setting aside of a public announcement dated May 2 to the limited extent that respondent-Harvana Public Service Commission (HPSC) had refused to invite fresh applications for holding preliminary examination of the Haryana Civil Services (Executive Branch) and other allied services.
