75. Ratification of the Action taken by the Vice-Chancellor in approving the recommendations of the Academic Council made vide Reso. No. 9 in its meeting dated 11.7.22 in anticipation of approval of Executive Council.

On the request of the Addl. Dy. Commissioner-cum-Vice-President, Indian Red Cross Society and Course Co-ordinator, Arpan Institute for Mentally Handicapped Children, Gandhi Nagar, Rohtak for extension in the last date for submission of Processing Fee to start M.Ed Special Education from the session 2022-23, the Vice-Chancellor constituted a committee. Consideration of the matter regarding extension in the last date for submission of proposal along with amendment/addition in Fee Structure duly approved by the Executive Council vide Reso. No. 52 dated 04.09.2019 for submission of proposal/request for establishment of new College/Institute/additional Program/Course/additional intake/extension/continuation in Provisional Affiliation for all type of colleges affiliated to M.D. University, Rohtak (Annexure A/128 Pages 427-434, already circulated).

As per Fee Structure already approved by the Executive Council vide its Reso. No. 52 dated 04.09.2019, the last date to apply for establishment of new college/institute/additional course/additional intake/extension/continuation in Provisional Affiliation for all type of colleges affiliated to M.D. University, Rohtak alongwith 100% late fee + 18% GST was 30.4.2022 for the session 2022-23, after which there is no provision for extension of date (Annexed above).

The committee submitted the Proceedings on 17.06.2022 (Annexure A/129 Page 435, already circulated) which were duly approved by the Vice-Chancellor and further the Academic Council vide Reso. No. 9 in its meeting held 11/07/2022 has resolved as under:

"Resolved that the Proceedings of the committee as above be implemented from the next session with the modification that GST will be charged as applicable from time to time. However, for this year, the last date for submission of proposal/request for establishment of new college/continuation in Provisional Affiliation for all type of Colleges affiliated to M.D. University, Rohtak be extended up to 31.08.2022 with 100% late fee as applicable up to 30th April + Rs. 50,000+GST as applicable.

Resolved further that the above be recommended to the Executive Council for consideration and approval".

As the meeting of the Executive Council scheduled on 18.07.2022 has already been postponed due to some administrative reasons and the extended last date for submission of proposal is 31-8-2022, and the admission process is going to start very soon. Accordingly, the case was submitted to the Vice-Chancellor who after due consideration approved the minutes of the meeting of the Academic Council in anticipation of approval of the Executive Council and allowed the office to take further action as well as to refer the case to Executive Council for consideration.

The Executive Council considered the action taken by the Vice-Chancellor on Reso. No. 9 recommended by the Academic Council in its meeting held on
