- (c) The compliance made by the College will be checked through an Inspection Committee constituted by the Vice-Chancellor and if the college fails to submit full compliance as mentioned at point no. (i) above within three(03)-months then the college shall be put in 'No Admission Category' again by the University and Bank Guarantee of Rs. 5.00 lacs submitted by the President of the society/Managing Committee of Vishwas College of Education, Pataudi, Distt. Gurugram will be encashed & forfeited. Thereafter the process of disaffiliation may be initiated against the college without any further notice.

Accordingly, the President, Vishwas Educational Society, Pataudi, Distt. Gurugram vide its letter bearing no. VES/2022/37 dated 21.1.2022 had submitted the required documents i.e. undertaking in the shape of affidavit that the management shall make full compliance of the deficiencies pointed out by the various Inspection Committees within stipulated period i.e. three months upto 31.3.2022 and Performance Bank Guarantee of Rs. 5.00 lacs in favour of Finance Officer, M.D. University, Rohtak along with an affidavit by stating that if the management fails to comply with the various deficiencies, the University authorities shall be free to take any action against the college as per University rules and regulations(Annexure A/41 pages 179-183, already circulated).

Whereas the President, Vishwas Educational Society, Pataudi, Distt. Gurugram vide its letter bearing No. VES/2022/41 dated 04/04/2022 has submitted compliance report made in the light of above E.C.Reso. No. 40(Annexure A/42 pages 184-185, already circulated). The Inspection Committee constituted by the Vice-Chancellor to check the compliance made by the College visited the College on 19.5.2022 and submitted its report on 20.5.2022 with the recommendations that the college has not complied with the deficiencies regarding appointment of teaching and non-teaching staff, strengthening of library and labs, as pointed out by the previous Inspection Committee(s) (annexed above).

The Vice-Chancellor considered and approved the above Inspection Report and passed orders that in the light of Executive Council Reso. No. 40 dated 31.12.2021(annexed above) (i) The college be put in 'No Admission Category' again for making admissions in B.Ed. program w.e.f. the session 2022-23, (ii) Bank Guarantee of Rs. 5.00 lacs already submitted by the President concerned be encashed and forfeited, (iii) Initiate the process for disaffiliation of Vishwas College of Education, Pataudi, Distt. Gurugram and allowed to Registration & Scholarship(R&S) Branch to initiate the process for shifting of students from Vishwas College of Education, Pataudi, Distt. Gurugram to nearby institute affiliated with this University thereafter.

Accordingly, the office has informed the President, Vishwas Educational Society, Pataudi, Distt. Gurugram that their college has been put in 'No Admission Category' again w.e.f. the session 2022-23 and endorsed a copy of the same to Dy. Registrar(R&S) to initiate the process for shifting of students of Vishwas College of Education, Pataudi, Distt. Gurugram to nearby Institute(s) affiliated with this University vide this office letters dated

23.5.2022(Annexure A/43 pages 186-187, already circulated). Further, the office vide letter bearing no. CB-IX/F-1002/2022/7913 dated 23.5.2022(Annexure A/44 page 188, already circulated) has requested the Finance Officer, M.D.U. Rohtak to get the bank guarantee of Rs. 5.00 lacs be encashed and forfeited.

Whereas, the Vice-Chancellor has ordered to refer the following to the Academic Council/Executive Council for consideration:

Disaffiliation of Vishwas College of Education, Pataudi, Distt. Gurugram for running B.Ed. regular course with an intake of 100 seats w.e.f. the session 2022-23 in the light of E.C.Reso. No. 40 dated 31.12.2021(Annexure A/45 page 189, already circulated), as the college has failed to comply with the deficiencies pointed out by Inspection Committee(s) within stipulated period up to 31.3.2022 (Annexure A/46 page 190, already circulated) and also allow the Registration & Scholarship (R&S) Branch to initiate the process for shifting of students from Vishwas College of Education, Pataudi, Distt. Gurugram to nearby Institute affiliated with this University.

The Academic Council vide Reso. No. 8 in its meeting held on 11.07.2022 considered the above proposal and resolved as under:
