IN THE FOLLOWING MANNER BY ADVERTISING THE SAME ON THE RESPECTIVE WEBSITES:

- I. Firstly, the vacant seats, if any, will be filled up by the candidates who have appeared in the Entrance Test.
- II. Secondly, the vacant seats, if any, after (i) above, will be filled up by the candidates who have registered for admission but did not appear in the entrance test.
- III. Thirdly, the vacant seats, if any, after (i) and (ii) above, will be filled up on the basis of Academic Merit by inviting fresh applications.

HOWEVER, ADMISSION TO VACANT SEATS OF 5 YEAR INTEGRATED PROGRAMS BEING RUN IN THE UTDs AND MDU-CPAS, GURUGRAM BE MADE ON THE BASIS OF ACADEMIC MERIT FROM THE EXISTING MERIT LIST AVAILABE WITH THE CONCERNED INSTITUTE/ DEPARTMENT (WHERE ADMISSIONS ARE MADE ON THE BASIS OF ACADEMIC MERIT). WHERE ENTRANCE TEST HAS BEEN CONDUCTED, SCORE OF ENTRANCE TEST MAY BE USED FOR FILLING UP THE VANCANT SEATS.

IT WILL BE THE SOLE RESPONSIBILITY OF THE CONCERNED HOD / DIRECTOR TO ARRANGE EXTRA CLASSES FOR SUCH STUDENTS TO COMPLETE THE SYLLABUS IN TIME.
