Provisional Affiliation for establishment of new College of Education in the name & Sub: style of "B.R.D.E.W.S. Baba Ramdas Institute of Special Education, VPO Nuna Majra, Firani Road, Bahadurgarh, Distt. Jhajjar, Haryana under Self Financing Scheme for running of B.Ed. Special Education(ID) course with an intake of 30 seats under SFS w.e.f. the Session 2022-23 in anticipation approval of the Executive Council of the University

Sir.

Kindly refer to your proposal vide letter ref. no. BRD/22-23/166 dated 02.08.2022 on the above noted subject.

I have been directed to inform you that on the basis of the recommendations of the Inspection Committee which visited your above proposed College on 29.08.2022 to verify/check the various infrastructural and instructional facilities etc., the Vice-Chancellor has been pleased to grant Provisional Affiliation for establishment of newly proposed College/Institute in the name & style "B.R.D.E.W.S. Baba Ramdas Institute of Special Education, VPO Nuna Majra, Firani Road, Bahadurgarh, Distt. Jhajjar" under Self Financed Basis for introduction/running B.Ed. Special Education(ID) regular course/program w.e.f. the session 2022-23 with an intake of 30 seats in anticipation approval of Executive Council and the decision of Executive Council will be binding on your College/Institute.

The Provisional Affiliation has been granted with the stipulation that your college/institute shall fulfill the deficiencies/make full compliance of the observations/shortcomings pointed out in the Inspection Committee in its report especially regarding appointment of teaching & non-teaching staff within two months from starting of classes as per RCI/MDU norms in accordance with the prescribed qualifications, norms and procedure of appointment in terms of RCI/State Govt./MDU norms as well as full compliance of the observations pointed out in the recognition letter of the RCI, New Delhi (copy enclosed). In case your college is found deficient of infrastructural facilities/teaching faculty, your college/institute will be liable for penalities and other action under the rules/Statute-38 of M.D.U. Act. The compliance of the shortcomings/deficiencies in this regard be sent to the University for necessary verification within the above stipulated period.

The above provisional affiliation is further subject to the following mandatory conditions:-

- 1. The College shall constitute Governing Body as per RCI/State Govt./University norms.
- 2. The admission will not exceed beyond the sanctioned intake.
- 3. The Teaching & Non-Teaching Staff shall be appointed through duly constituted selection committee, CPF scheme must be introduced. Service Rules for teaching/non-teaching staff framed by the RCI/State Govt./MDU shall be followed strictly.
- 4. The fee structure prescribed by the State Govt./University shall be strictly followed.
- All Academic, Physical and other infrastructural facilities shall be continued to be provided/ upgraded by the College/Institute as prescribed by the RCI/State Govt./University from time to time.
- The College/Institute shall furnish requisite documents and reports as called for by the University from time to time in order to ensure proper maintenance of the infrastructural facilities and academic standards.
- 7. The information furnished in respect of above course shall be factual and correct. In the event of any information found to be false, misleading or suppressed the provisional affiliation shall be withdrawn by the University without any notice.
- 8. In the event of non compliance of the University Act/Statues/Ordinances/Rules and Regulations and any other instructions/guidelines issued from time to time, the University shall be free to withdraw the provisional affiliation and all liabilities arising out of such a withdrawal would solely lie on the concerned society/college.
- The College shall provide all academic and infrastructural facilities including class-rooms, hostels, library, laboratories, workshops, play grounds and other amenities required for smooth conduct of its affairs as per State Govt./University rules.
- 10. The College/Institute shall not shift its original site without prior approval of RCI/MDU.
- 11. <u>Building</u>: The entire building of the College will be at the disposal of the Controller of Examinations for the purpose of conduct of examinations as and when, the Centre of Examination (for theory and practical both) is created it will be obligatory for the Principal to provide necessary infrastructure for smooth conduct of examination.
- 9. Examination Centre: Creation of an Examination Centre in the College/Institute will be at the discretion of the Controller of the Examinations. The Centre of Examinations for the students studying in the College/Institute can be shifted to any other college. In such a situation, it will be responsibility of the Institutution/College to make arrangements for transporting the students to the Centre of Examinations without any extra charges from the students. Similarly, the University can also shift the students of other colleges/institutes to the college/institution under reference for which necessary infrastructure will have to be provided by the Principal concerned.
- 10. <u>Staff</u>: For the purpose of conduct of examinations, the services of entire teaching & non-teaching staff will be at the disposal of the Controller of Examinations. The examination duties can be assigned to any member of teaching and non-teaching staff which will have to be complied with, in the interest of smooth conduct of examinations.
- 11. Strong Room: There will be a Strong Room in the College at the prime location-adjacent to the office of the Principal to keep the confidential material of the University as and when required. The Strong Room will essentially have double lock system.

You are, therefore, directed to complete the above said requirements/shortcomings/ conditions and send compliance report of the same to this office within the given stipulated period, so that the college be inspected by the University to verify the compliance. In case of noncompliance of above conditions/requirements within the stipulated period, the Registration of the Students of your College/Institute shall not be allowed and University shall have the right to refuse extension/continuation in Provisional Affiliation to your College/Institute for the next academic session.
