1. Considered* the request received from various affiliated Colleges/ Institutes for increase of 10% to 20% seats in various UG/PG Programs for the session 2022-23.

RESOLVED THAT THE REQUESTS AS ABOVE BE NOT ACCEDED TO AT THIS BELATED STAGE AS THE DGHE, HARYANA, PANCHKULA HAS NOT NOTIFIED WITH REGARD TO INCREASE OF SEATS IN THE COLLEGES SO FAR.
