

TERMS AND CONDITIONS

1. Only the firms having GST No. /PAN No. can quote their rates.
2. The quotation must be submitted latest by 28/9/2022 in the office of Incharge (Gen. Admn.), M.D. University, Rohtak.
3. The quotation that does not satisfy subject to the specifications, are liable to be rejected summarily. The University shall reserve the right to reject any quotations without assigning reasons.
4. The Price quoted will be applicable to the specifications mentioned" and will remain valid for at least 90 days.
5. The Committee shall reserve the right for negotiation on rates quoted thereafter, if considered necessary.
6. The successful Firm/Contractor will have to supply all the required materials and undertake the assigned work of various University Depts./Offices/Branches etc. on priority basis on placement of order in writing as well as verbal (if emergency so calls).
7. The acceptance of material is subject to the approval for the inspection Committee.
8. The security arrangements of the material will be made by the contractor/firm itself.
9. The successful contractor/firm will be bound to do the job (big or small) assigned to him from time to time. If the firm/contractor fails to do the arrangements, same may be debarred from the contract and legal action may also be taken.
10. In the event of non-completion of job in time or any complaint against the firm/contractor, the contract can be discontinued at any time and your Security Money of Rs.10,000/- shall also be forfeited.
11. No advance payment/cartage charges/breakage charges will be made by the University and payment will be made after completion of the assigned work/job.
12. GST as applicable will be given extra.
13. The payment will be made through cheque/ RTGS against the PAN No. supplied by the concerned firm and TDS will be deducted as per rules.
14. The successful firm/contractor will have to deposit an amount of Rs.10,000/- in favour of Finance Officer, M.D. University, Rohtak and also to submit an affidavit on non-judicial stamp paper of Rs.100/- for compliance the Terms & Conditions as prescribed by the University.
15. In case of dispute if any, decision of the University authorities will be final and binding upon you in all matters regarding this contract. The jurisdiction of court for any kind of dispute will be at Rohtak.
