On the basis of the recommendations made by the Inspection Committee, the Vice-Chancellor has been pleased to grant extension/continuation in provisional affiliation for LLB (Hons)- 3 year course with intake of 120 seats for/from the session 2021-22.

This extension/continuation is granted subject to compliance of the deficiencies pointed out by the committee. You are, therefore, requested to make the compliance of the deficiencies pointed out by the Inspection Committee as well as for adhering to the norms/standard laid down by the Central Body/M.D.University and to submit the compliance report to the University at the earliest for further verification by the University, failing which necessary action as per rules will be initiated by the University. A copy of the inspection report is also enclosed for ready reference.

Further, regarding provisional affiliation for introduction of LLM Course with an intake of 30 seats from the session 2021-22 shall only be granted after minimum requirements for teaching and support staff are met for the existing courses i.e. more than 25 out of 50 marks and the college first to comply with the deficiencies pointed out by the Inspection Committee in its report and apply afresh for the LLM Course as per schedule prescribed in fee structure.
