1. Considered the representation of the students for increase in seats of various 3 Year, 4 Year, 5 Year and 6 Year Integrated Programs being run in the UTDs/ Institutes and MDU-CPAS, Gurugram for the session 2022-23.

RESOLVED THAT THE SEATS IN THE FOLLOWING PROGRAMS MAY BE INCREASED AS UNDER IN ANTICIPATION OF APPROVAL OF THE ADMISSION COMMITTEE OF THE UNIVERSITY:

THE ADMISSIONS ON THESE INCREASED SEATS MAY BE MADE BY THE DEPARTMENT/INSTITUTE BY ADVERTISING THE SAME ON THE UNIVERSITY WEBSITE AND FILLING THESE VACANT/ CREATED SEATS BY ADOPTING THE SAME PATTERN AT THEIR OWN LEVEL AND THE ADMISSIONS BE MADE ON 22.09.2022 KEEPING IN VIEW OF THE RESERVATION POLICY AND THE MERIT LIST (ACADEMIC MERIT/ ENTRANCE TEST, WHEREVER PRESCRIBED) THROUGH PHYSICAL COUNSELLING. THE HEAD/ DIRECTOR CONCERNED WILL MAKE UP THE LOSS OF CLASSES OF SUCH STUDENTS BY ARRANGING EXTRA CLASSES FOR THEM.

2. Considered the request received from Mr. Vishnu Kumar S/o Sh. Jai Narayan, Reg. No. 1618280025 with regard to award of Gold Medal as he has passed M.Phil (Music) with first position.

THE COMMITTEE OBTAINED THE DETAILED FACTS FROM THE HoD MUSIC AND THE CONTROLLER OF EXAMINATIONS, AND FOUND THAT THE STUDENT IS COVERED UNDER THE EXISTING PROVISIONS OF THE ORDINANCE FOR AWARD OF GOLD MEDAL AS THERE IS NO BAR ON THE NUMBER OF STUDENTS IN A PROGRAM. THEREFORE, THE STUDENT MAY BE AWARDED GOLD MEDAL BY THE UNIVERSITY.

3. Considered the request of Mr. Parshant S/o Sh. Jagmohan Singh resident of Kanheli, Rohtak, Reg. No. 1418380174 for admission to B.Tech. 7th semester at much belated stage as he left B.Tech. Program after 6th semester in 2017 due to his joining in Merchant Navy.

THE COMMITTEE FOUND THAT AS PER EXISTING PROVISION OF B.TECH ORDINANCE AND THE COMMENTS OF THE DIRECTOR (UIET), THE STUDENT HAS DONE AWAY WITH HIS ALL CHANCES TO COMPLETE B.TECH PROGRAM. HOWEVER, THE DIRECTOR (UIET) MAY SEEK CLARIFICATION FROM THE AICTE WHETHER THIS APPLICANT CAN BE ALLOWED BY THE UNIVERSITY TO TAKE ADMISSION IN B.TECH. 4TH YEAR (7TH SEMESTER AND 8TH SEMESTER) EVEN AFTER THE COMPLETION OF NORMALLY ALLOWED PERIOD.

4. Considered the various representations/Grievances received from applicants of M.A. Economics (Hons.) 5-Year Integrated Program with regard to anomalies in admissions and the roster register being maintained by the Department.

THE HoD (ECONOMICS) PRESENTED THE DETAILED FACTS AND FIGURES BEFORE THE COMMITTEE WITH REGARD TO ROSTER REGISTER FOR ADMISSION TO M.A. ECONOMICS (HONS.) 5-YEAR INTEGRATED PROGRAM AND FOUND THAT THE ADMISSIONS HAVE BEEN MADE BY THE DEPARTMENT AS PER UNIVERSITY GUIDELINES MENTIONED IN THE PROSPECTUS FOR THE SESSION 2022-23.
