**Sub: Extension of last date for admission to 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> semesters of UG/PG Programs for the session 2022-23.**

Sir/Madam,

In continuation to the office letter No. AC-VI/22/F-86/18181-18270 dated 08.09.2022 on the subject cited above, I am directed to inform you that the Vice-Chancellor has been pleased to approve the following:-

- (i) The last date for admission to intermediate semester i.e. 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> semesters (as the case may be) be extended upto 10.10.2022 (with existing late fee of Rs. 1,000/- per student) for UTDs & M.D.U CPAS, Gurugram.
- (ii) The last date for admission to intermediate semesters i.e. 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> semesters (as the case may be) in the affiliated Colleges/Institutes will remain the same i.e. 27.09.2022, as notified by the DGHE vide letter dated 22.09.2022. Further, the last date for admission to these semesters, if extended, by the DGHE, shall also be applicable with existing late fee of Rs. 1,000/- per student. This late fee will be remitted to the University with Continuation Return, the schedule for which will be notified by the R&S Branch of this University.
- (iii) The HoDs/Principals/Directors will ensure to arrange extra classes for such students.
- (iv) The concerned students, who could not take admissions to intermediate semesters yet, may be informed telephonically or through SMS etc. by the Department/Colleges/Institutes.
- (v) No further date will be extended beyond 10.10.2022 so as to complete the required teaching days in a semester as per University norms.
