Copy of extract of Reso. No. 53/26 of Executive Council's meeting held on 20/7/22.

53 (36) To apprise regarding putting Shri Balaji College of Education, Sampla, Distt. Rohtak in No Admission Category for admission to B.Ed. & M.Ed. regular course(s) w.e.f. session 2020-21 and disaffiliation of College from the session 2023-24.

The Principal, Shri Balaji College of Education, Delhi-Sampla By Pass, Rohtak Road, Sampla, Distt. Rohtak requested for closure of B.Ed. and M.Ed. courses from the session i.e. 2020-21 and in this regard they also requested to the Central Body i.e. NCTE for closure of B.Ed. and M.Ed. courses from the session 2020-21. The request of the college was submitted to the Vice-Chancellor and he allowed to place the College under "No Admission Category" for admission to B.Ed. and M.Ed. regular courses from the session 2020-21.

The College was put under 'No Admission Category' after obtaining orders of the Vice-Chancellor, but the matter was not placed before the Academic Council/ Executive Council by the dealing concerned as per requirement of the Statute-38 and while considering the matter, the Vice-Chancellor has constituted a Fact Finding Committee for recommendation/report. The committee submitted its report and it was approved by the Vice-Chancellor and a three (03) member's committee for preparation of SOP has been constituted by the Vice-Chancellor.

Further, the office has received "Orders for Closure/Withdrawal of recognition" of Shri Balaji College of Education, Delhi Sampla By Pass, Rohtak Road, Sampla, Distt. Rohtak Haryana from the NCTE, New Delhi.

The Academic Council vide Reso. No. 75 in its meeting held on 15.07.2023 considered the above and passed the following resolution:

RESOLVED TO ACCEPT THE REQUEST OF THE COLLEGE FOR CLOSURE AS MENTIONED ABOVE AND PLACING BEFORE THE EXECUTIVE COUNCIL WITH RECOMMENDATIONS FOR ACCEPTANCE.
