NOTIFICATION

The Executive Council in its meeting held on 19.12.2022 considered the recommendations of the committee constituted by the Vice-Chancellor regarding non-deduction of TDS on Leave Encashment and Perquisites, on the pattern of Kurukshetra University and as per order issued by ITAT. The Executive Council vide Resolution No. 73 resolved the following in this regard:

i) An affidavit may be obtained from the employees as per specimen

(overleaf) on Non-judicial paper duly attested by Notary Public.

ii) It may be clearly mentioned in the said affidavit that in case, instructions contrary to the above are received from the Income Tax Authorities later on, he/ she shall be liable to pay the amount recoverable from them as Income Tax/ Penalty, as per rules.

iii) It will be a constituent of the declaration of the Annual Income Tax Statements. Further, the said affidavit shall also be a constituent of "No Dues Certificate" (NDC) and the Establishment Branch shall obtain the

same from the concerned university employee.

Accordingly, the interested University employee are required to submit an affidavit (specimen overleaf) on non-judicial paper duly attested by minimum a Notary Public mentioning therein that in case, instructions contrary to the above are received from the Income Tax Authority later on, he/ she shall be liable to pay the amount recoverable from them as Income Tax, as per rules and henceforth, it will be constituent of the declaration of the Annual Income Tax Statement to the concerned Establishment Branch with a copy of the said affidavit to the Accounts Branch.
