42. Ratification of the action taken by the Vice-Chancellor in anticipation of approval of the Executive Council regarding grant of Provisional Affiliation for establishment of newly proposed (Jain Minority College) in the name & style of Mahaveer Swami College of Education, Plot/Khasra No. 44/1, 44/6, 44/10, Village Jagdishpur, Post Office – Raathdhana, Tehsil/Taluka – Sonapat, Town/City – Sonapat, Distt. Sonapat, Haryana - 131030 under SFS for running B.Ed. course with an intake of 100 seats w.e.f. the session 2022-23

By considering the request(s) of the Chairman, Bhagwan Mahavir Education Foundation dated 26.07.22, 04.08.22 & 14.09.22 (Annexure A/77 pages 448-457, already circulated), the Vice-Chancellor constituted an Inspection Committee for establishment of newly proposed Jain Minority Education College in the name & style of "Mahaveer Swami College of Education, Plot/Khasra No. 44/1, 44/6, 44/10, Village Jagdishpur, Post Office – Raathdhana, Tehsil/Taluka – Sonapat, Town/City – Sonapat, Distt. Sonapat, Haryana - 131030" for running of B.Ed. regular program with an intake of 100 seats w.e.f. the session 2022-23 under SFS on the basis of infrastructural facilities, faculty and other support system available in the said proposed College as per norms of the central body i.e. NCTE, State Govt., MDU, Rohtak w.e.f. the session 2022-23 (Annexure A/76 pages 446-447, already circulated).

The Inspection Committee duly constituted by the Vice-Chancellor visited the proposed College on 04.10.2022 for verifying the required infrastructural facilities and other support systems including faculty etc. as per central body i.e. NCTE/State Govt./MDU norms and submitted its report (Annexure A/76 pages 446-447, already circulated). On the basis of observations, the committee recommended for grant of Provisional Affiliation for establishment of newly proposed college in the name and title of "Mahaveer Swami College of Education, Jagdishpur, Sonapat" for running B.Ed. course with an intake of 100 seats from the session 2022-23 (Annexure A/78 pages 458-459, already circulated).

The report of the Inspection Committee was submitted to the Vice-Chancellor who has ordered to place the matter before the Academic Council for consideration.

The report of the Inspection Committee has been considered by the Academic Council in its meeting dated 19.10.2022 vide Item/Reso. No. 53 and it has been resolved that the Inspection Report of the committee for grant of Provisional Affiliation for establishment of the newly proposed Jain Minority College be recommended to the Executive Council for its consideration.

Further, as no meeting of Executive Council was scheduled and the admission process for B.Ed./M.Ed. regular programs was going to be started w.e.f. 26.10.2022, therefore, the Vice-Chancellor has considered and approved the minutes of the Reso. No. 53 of Academic Council in anticipation approval of the Executive Council.
