41. Ratification of the Action Taken by the Vice-Chancellor in approving the minutes of the Academic Council vide Reso. No. 52 in its meeting dated 19.10.2022 in anticipation of approval of the Executive Council for grant of Provisional Affiliation for establishment of newly proposed Institute in the name & style of "B.R.D.E.W.S. Baba Ramdas Institute of Special Education, VPO Nuna Majra, Firani Road, Bahadurgarh, District Jhajjar, Haryana - 124507" under S.F.S. for running of B.Ed. Special Education (I.D.) course with an intake of 30 seats w.e.f. the session 2022-23.

By considering the request dated 02.08.2022 of the President, Baba Ramdas Educational Welfare Society(Regd.), Line Par, Bahadurgarh-124507(Annexure A/74 pages 436-443, already circulated), the Vice-Chancellor constituted an Inspection Committee to verify the infrastructural facilities, faculty and other support system available as per norms of the central body i.e. RCI/State Govt./MDU, Rohtak for establishment of new Education Institute in the name & style of "B.R.D.E.W.S. Baba Ramdas Institute of Special Education, VPO Nuna Majra, Firani Road, Bahadurgarh, District Jhajjar, Haryana - 124507" under S.F.S. for running B.Ed. Special Education(I.D.) regular program with an intake of 30 seats w.e.f. the session 2022-23 (as approved by the Central Body i.e. RCI, New Delhi) (Annexure A/75 pages 444-445, already circulated).

The Inspection Committee duly constituted by the Vice-Chancellor visited the proposed institute on 29.08.2022 and submitted its report (Annexure A/73 pages 434-435, already circulated). On the basis of observations, the committee recommended for grant of Provisional Affiliation for establishment of newly proposed Institute in the name & title of "B.R.D.E.W.S. Baba Ramdas Institute of Special Education" for running of B.Ed. Special Education (ID) course with an intake of 30 seats w.e.f. the session 2022-23 (Annexure A/73 pages 434-435, already circulated).

The report of the Inspection Committee was placed before the Vice-Chancellor who had ordered to place the matter before the Academic Council for consideration.

The Academic Council vide Reso. No. 52 dated 19.10.2022 has resolved that the Inspection Report of the committee for grant of Provisional Affiliation for establishment of newly proposed institute be recommended to the Executive Council for consideration.

Further, as no meeting of Executive Council was scheduled and the admission process for B.Ed./M.Ed. regular programs was going to be started w.e.f. 26.10.2022, therefore, the Vice-Chancellor has considered and approved the minutes of the Reso. No. 52 of Academic Council in anticipation of approval of the Executive Council.
