33. Ratification of the Action Taken by the Vice-Chancellor for Granting Provisional Affiliation to Shivom Rehabilitation Centre, VPO Nigana, Distt. Rohtak for introduction of B.Ed. Special Education (I.D.) regular Program/Course under SFS

By considering the request of the President, Shivom Educational Society, V.P.O.Nigana, Distt. Rohtak, the Vice-Chancellor constituted an Inspection Committee to check the infrastructural and instructional facilities for grant of Provisional Affiliation to a newly proposed College in the name & style of 'Shivom Rehabilitation Centre, VPO Nigana, Distt. Rohtak under SFS for introduction/running of B.Ed. Special Education(I.D.) regular program with intake of 30 seats w.e.f. the session 2022-23(Annexure A/56 pages 389-395, already circulated). Accordingly, the committee constituted by the Vice-Chancellor visited the proposed college on 11.06.2022 and submitted the Inspection Report (Annexure A/57 pages 396-399, already circulated). On the basis of observations made in the Inspection Report, the Inspection Committee has made the following recommendation:

1. "In category of Infrastructure C+D+E, Institute score is 75% and in category F. Score is 87.5% as mentioned in Proforma.
2. Institute has to start new course of B.Ed. Spl. Education with intake of 30 students and has identified the faculty & support staff and also give undertaking to appoint the staff as per M.D.University, Rohtak norms & procedure and qualifications as per RCI. The committee verifies that the Institute has requisite infrastructural facilities as per the norms of the Central Body i.e. RCI, New Delhi. New course is to be started by the Shivom Rehabilitation Centre, VPO Nidana of B.Ed. Spl. Education(ID).
3. The committee recommends the starting of B.Ed. Special Education(ID) with intake of 30 students from the session 2022-23 subject to the condition that the institute shall appoint required teaching and non-teaching staff within two months of starting of classes.

Accordingly, the report of the Inspection Committee (Annexed above) was submitted to the Vice-Chancellor, who after due consideration has approved the said Inspection Report in anticipation of approval of the Academic Council/ Executive Council w.r.t. grant of Provisional Affiliation for opening of newly proposed College/institute for introduction/starting of new course i.e. B.Ed. Special Education(I.D.) w.e.f. the session 2022-23 in the name & style of 'Shiv Om Rehabilitation Centre' VPO Nigana, Distt. Rohtak as no meeting of Academic Council/Executive Council was scheduled in near future.

The Academic Council vide Reso. No. 35 of its meeting held on 19.10.2022 has considered the matter and recommended the following:

RESOLVED THAT THE ACTION TAKEN BY THE VICE-CHANCELLOR AS ABOVE BE RATIFIED AND RECOMMENDED TO THE EXECUTIVE COUNCIL FOR ITS CONSIDERATION AND APPROVAL.

The Executive Council considered the recommendations of the Academic Council, and

RESOLVED THAT THE RECOMMENDATIONS OF THE ACADEMIC COUNCIL AS ABOVE BE APPROVED.
