Sir/Madam,

The applications are invited for hostel accommodation in Girls Hostels for the session 2023-2024.

• **Submission of Admission Form**

1. The admission in the hostel for students admitted in University Teaching Departments will be made Online through Student Portal (<https://student.mdu.ac.in>). HBI for the session 2023-2024 & User Manual to fill up the Hostel Admission form online, available on University Website.
2. Each student has to upload residential proof (any one) i.e. Aadhar Card/Voter Card/Driving Licence/Passport/Ration Card, while filling up the Hostel Admission Form. This is mandatory.
 - (i) Each student has to select the undertaking of not to indulge in any kind of ragging activities.
 - (ii) Each student has to select the undertaking regarding hostel rules/ regulations.

3. **Documents to be submitted by the student along with printout of Hostel Admission Form.**

- (i) Each student has to submit six passport size latest photographs without attestation.

• **Eligibility**

1. Accommodation in the University Hostels is available only to the bonafide students admitted to University Teaching Programs in the UTD and except the following:
 - i) Student whose residence/house is within the distance of 30 km from MDU Rohtak. For providing wrong information, the student will be expelled from the hostel and the matter will be forwarded to the University authorities for strict disciplinary action.
 - ii) Day Scholars, Bus Pass Holders, Students admitted to evening Programs except LLM (evening), Students admitted to CDOE/Diploma (except DISLI/DTISL)/ Certificate courses, Students pursuing 2nd (second) UG/PG program from MD University. Students who are employed part time/full time in any organization or are self-employed or involved in/taking up any other gainful employment, professional work/assignment.
 - iii) Students expelled in the past from M.D.U. Hostels and University Teaching Departments.
 - iv) Only those Ph. D scholars are eligible to get admission in University Girls Hostels who have been availing URS or Scholarship/Fellowship from any Central/State Government funding Institutions and whose attendance in the Department is mandatory. The entitlement for Hostel accommodation for such Ph. D scholars shall be up to the expiry of the fellowship.

The Merit List of only those students should be prepared for admission to hostels whose Village/Towns are most than 30 Kms away from the University.

• **Preparation of Merit List**

1. Concerned HOD/Director will forward the merit list strictly following the Haryana State Government Reservation policy and the ensuing following criteria for the preparation of merit list.

(i) **Distance (Max Score: 20)**

Score for distance shall be calculated by taking 5 % of distance up to a maximum 20 marks.

(ii) **Academic Merit (Max Score: 30)**

Academic merit will be calculated by taking 30% of the marks obtained in the previous semester/ year/latest result declared by University (in case of Promote students reappear zero marks).

Academic merit will be calculated by taking 30% of the marks obtained in the qualifying academic program (in case of new admission).

Computation of merit list for admission in hostels shall be prepared by using the formula

Academic Merit Score (Out of 30) + Distance Score (Out of 20)

For example, if a student is having 80% marks in previous semester and distance of his residence is 350 kms, his merit score will be computed as follows

24 + 17.5 = 41.5 i.e. 30% of 80 = 24 for academic merit + 17.5 for distance.

The distance will be measured from the residential address city/village as mentioned in residential proof attached by the student and computed through Google Map/verification from the concerned Haryana Roadways office.

Note:- 20% seats are reserved for SC/ST students in each hostel as per state government reservation policy w.e.f. 2021-2022.

5. Payment of Hostel Fee: 25.07.2023 to 28.07.2023

The HOD/Director should forward the complete list of students to be admitted (as per seat matrix) in one lot. Hard copy of the merit list along with the admission forms be forwarded to the concerned Girls Hostel Warden and a soft copy be forwarded to the office of Chief Warden (Girls) at email: chiefwarden.girls@mdurohtak.ac.in

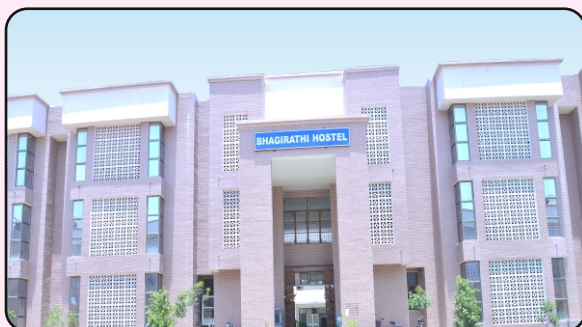

SECTION – I
ADMISSION PROCEDURE IN GIRLS HOSTELS

- **Eligibility**

1. Accommodation in the University Hostels is available only to the bonafide students admitted to University Teaching Programs in the UTD and except the following:
 - i) Student whose residence/house is within the distance of 30 km from MDU Rohtak. For providing wrong information, the student will be expelled from the hostel and the matter will be forwarded to the University authorities for strict disciplinary action.
 - ii) Day Scholars, Bus Pass Holders, Students admitted to evening Programs except LLM (evening), Students admitted to CDOE/Diploma (except DISLI/DTISL)/Certificate courses, Students pursuing 2nd (second) UG/PG program from MD University. Students who are employed part time/full time in any organization or are self-employed or involved in/taking up any other gainful employment, professional work/assignment.
 - iii) Students expelled in the past from M.D.U. Hostels and University Teaching Departments.
 - iv) Only those Ph. D scholars are eligible to get admission in University Girls Hostels who have been availing URS or Scholarship/Fellowship from any Central/State Government funding Institutions and whose attendance in the Department is mandatory. The entitlement for Hostel accommodation for such Ph. D scholars shall be up to the expiry of the fellowship.

- **Renewal of Hostel Admission**

- i) The residents who are promoted to next class of their respective programs shall be required to submit renewal forms in each academic session.
- ii) The bonafide resident whose result is awaited must apply in time but final allotment may be granted only after the declaration of the results subject to the availability of seats in the hostel.

- **The renewal of Hostel admission would only be granted to those:**

- i) Who have been promoted to next class/semester and are eligible.

- ii) Who have cleared all hostel dues before appearing in the annual/semester examination.
- iii) Whose conduct report issued by the respective Warden is satisfactory.
- **The following student/students shall not be eligible for admission / renewal in the hostel:**
 - i) Those who were detained from appearing in examination by the university authorities.
 - ii) Those who did not appear in the examination on their own without any valid reason.
 - iii) Those who got reappear in the previous declared result.
 - iv) Disciplinary action(s) was/were taken against her/them by the university authorities.
 - v) Those who violated hostel rules/ laws or has/have been found guilty to breach hostel discipline and/or has/have been reprimanded, fined, or punished in any way by the Chief Warden/ Deputy Chief Warden/Wardens.
 - vi) Those who are employed part time/full –time in any organization or are self-employed or involved in/taking up any other gainful employment, professional work/assignment.

SECTION – II

- **Submission of Admission Form**

1. The admission in the hostel for students admitted in University Teaching Departments will be made Online through Student Portal (<https://student.mdu.ac.in>).

Ph.D :

Only those Ph. D scholars are eligible to get admission in University Girls Hostel who have been availing URS or Scholarship/Fellowship from any Central/State Government funding Institutions and whose attendance in the Department is mandatory. The entitlement for Hostel accommodation for such Ph. D scholars shall be up to the expiry of the fellowship and there after, the scholar shall have to make his own arrangement.

- (i) Each student has to select the undertaking of not to indulge in any kind of ragging activities.
- (ii) Each student has to select the undertaking regarding hostel rules/ regulations.

2. **Documents to be submitted by the student along with printout of Hostel Admission Form.**

- (i) Six passport size latest photographs without attestation.
- (ii) The undertaking against Ragging.
- (iii) All undertakings regarding hostel rules.
- (iv) An attested photocopy of last attended University examination from the HOD concerned.
- (v) A guest list along with the photograph of the parents and their guardians attested by the parents to be submitted by the parents at the time of admission of the candidate.
- (vi) The Students are permitted to own/ use Two Wheelers. Each such student shall have to furnish the vehicle information (Copy of the Registration Certificate of the vehicle and Driving License) at the time of admission.
- (vii) **Ph. D Students have also to fill in and upload an additional proforma Annexure-A (Available in the office of hostel) countersigned by respective Supervisor/Guide and HOD/Director for their admission in the university hostel for their admissions in the university hostel along with the following documents: detail of attendance register, detail of fellowship and proof of registration.**

SECTION - III

- **Preparation of Merit List**

1. Concerned HOD/Director will forward the merit list strictly following the Haryana State Government Reservation policy and the ensuing following criteria for the preparation of merit list.

- (i) **Distance (Max Score: 20)**

Score for distance shall be calculated by taking 5 % of distance up to a maximum 20 marks.

- (ii) **Academic Merit (Max Score: 30)**

Academic merit will be calculated by taking 30% of the marks obtained in the previous semester/ year/latest result declared by University (in case of Promote students reappear 0 marks).

Academic merit will be calculated by taking 30% of the marks obtained in the qualifying academic program (in case of new admission).

Computation of merit list for admission in hostels shall be prepared by using the formula

Academic Merit Score (Out of 30) + Distance Score (Out of 20)

For example, if a student is having 80% marks in previous semester and distance of his residence is 350 kms, his merit score will be computed as follows

$24 + 17.5 = 41.5$ i.e. $30\% \text{ of } 80 = 24 \text{ for academic merit} + 17.5 \text{ for distance.}$

The distance will be measured from the residential address city/village as mentioned in residential proof attached by the student and computed through Google Map/verification from the concerned Haryana Roadways office.

2. The HOD/Director shall forward the complete list of students to be admitted (as per seat matrix) in one lot. A hard copy of the merit list along with the admission forms shall also be forwarded to the concerned hostel Warden and a soft copy be forwarded to the office of Chief Warden (Girls) at email: chiefwarden.girls@mdurohtak.ac.in

SECTION – IV

- **Rules & Procedure for Allotment of Rooms**

1. Right of admission to the University Girls Hostels is reserved with the Chief Warden (Girls).
2. Rooms will be allotted by the Warden and countersigned by the concerned Deputy Chief Warden/Chief Warden.
3. In case the student did not take admission within a period of 5 days (from the date merit list is sent to the Chief Warden Office) the seat will be offered to the candidate next in the merit list. After admission if the possession of the rooms is not taken within a period of 10 days, admission will be cancelled, and the fee will not be refunded in any case.

Each admitted student must **bring her** parents (mother and/or father), along with their Aadhar Card and two recent family photographs in the concerned hostel. However, if mother / or father are not alive, their death certificate must be attached. In this case the applicant can **bring** her sister/guardian along with her Aadhar Card and two recent collective photographs endorsed by the HOD of the respective department in which she has taken the admission.

4. Upon arrival, the student will report to the Hostel Supervisor and will take possession of the room after signing the inventory of the furniture, electrical and other items in the room.
5. Two (2) seats are reserved for foreign students in each hostel and 20% seats are reserved for SC/ST students in each hostel as per state government reservation policy w.e.f. 2021-22.
6. Fresher/Junior students will be allotted dormitories.
7. No student would be admitted in the hostel without the recommendation of the HOD. All the applications must reach the Office of the concerned Hostel Warden, within the stipulated time.
8. Residents are not permitted to shift from the allotted room in any case without due permission through proper channel from the Chief Warden.

- **Facilities Available for Hostel Residents:**

1. Round the clock Security.
2. Ambulance facility.

3. Periodic Health checkup camps by the Youth Red Cross.
4. Cooperative Mess facility.
5. A well-furnished Common Room with LCD facility, Reading Room with magazine and newspaper are available in each hostel.
6. Sanitary Napkins Vending machines are available in the Girls Hostels.
7. Periodic Psychological and personnel counseling.
8. Regular Yoga and Aerobic sessions.
9. Personalized care for Hostel Residents.
10. Spiritual sessions for meditation and stress-management.
11. Opportunity for participation in Outreach Activities.
12. Hand-holding of the residents by mentors.

- **Grievance Redressal Mechanism**

There is separate Grievance Redressal Committee for the hostels headed by the Chief Warden.

- i) Any grievance from a resident should be first referred to the concerned Warden who shall, depending upon the nature of the grievance, ensure that it is processed by her as speedily as possible and in no case later than three days from the date of receipt of the grievance/ complaint.
- ii) In case the resident is not satisfied with action taken by the Warden, she as the case may be, is free to bring the grievance/complaint in writing to the notice of the Deputy Chief Warden as soon as the decision of the Warden has been notified and in no case later than three days from the date of decision of the concerned Warden. The Deputy Chief Warden shall resolve the grievance in no case later than three days from the receipt of the grievance/ complaint.
- iii) The complaint will be made to the Deputy Chief Warden along with the copy of the decision of the Warden.
- iv) If still not satisfied, the resident may appeal against the decision of the Deputy Chief Warden in writing to the Chief Warden with a copy of the decision of the Deputy Chief Warden and the Warden.
- v) The Chief Warden shall forward the Complaint/ appeal of the resident to the following Hostel Grievance Redressal Committee in order to resolve the matter/issue.

- a. Chief Warden Convener
 - b. Deputy Chief Warden Member
 - c. All the Wardens -do-
 - d. Three Regular Hostel Residents -do- (To be nominated by the Chief Warden in consultation with the Deputy Chief Warden)
- vi) If the Hostel Grievance Committee fails to solve the problem within a week, the Chief Warden would report the matter to the Vice-Chancellor.

Note: The residents must follow the above hierarchical order for reporting their grievances /complaints and should not violate in any case. The complainant bypassing the above channel and reporting directly to the Higher Authorities, shall be liable for disciplinary action.

SECTION - V

- **General Rules for Hostellers**

DO'S

Admissions shall be sought afresh in every academic session and the residents will conform to the following:

- a) A copy of the application form duly signed by the parents/guardian of the resident and recommended by the HOD/Director of the respective Deptt./Institute/Centre etc. has to be submitted to the hostel.
- b) The candidates selected for admission in the hostels are required to submit an undertaking that they will not handover their rooms to anybody else and vacate the hostel room within 48 hours after the completion of theory examinations/practical examination/30th June 2024, whichever is earlier. In case of Ph.D. students, the research scholars shall have to vacate the room in the hostel within 48 hours after the date of their viva-voce examination. The research scholars who have submitted their Ph.D. thesis shall not be considered for fresh admission in the hostel.
- e) Before leaving the hostel, every resident shall obtain clearance from the Hostel Supervisor/ Warden and personally hand over the charge of the room and hostel property to the Hostel Supervisor. A penalty of Rs. 500/- will be imposed on the defaulter.
- f) The residents are required to keep the hostel Identity Card (issued by Warden Office) with them all the time otherwise they will be treated as outsiders.

DONT'S

The hostel resident will not indulge in the following:-

- i) Damage to the hostel property.
- ii) Mutual shifting of rooms is not allowed without the permission of Chief Warden.
- iii) Ragging is strictly prohibited. In case of violation, expulsion from the hostel as well as legal case may be filed against the accused.
- iv) Smoking is strictly prohibited. In case anyone found, a fine of el. Rs. 500/- will be imposed. In case of repeated violation Rs. 1000/- and expulsion from the hostel.
- v) Use of alcohol is strictly prohibited. Any violator is to be fined Rs. 5000/- and expulsion from the hostel.

- vi) Drug abuse will be treated as a crime and invites a fine of Rs. 5000/- and expulsion from the hostel.
- vii) Indulgence in political activities and holding of demonstration in the hostel-premises is not allowed. Strict disciplinary action including cancellation of admission in hostel as well as in the department would be taken for violation.
- viii) Residents must bring their own LED/CFL/Tube and are not allowed to use more than one. They must switch off the light while going out of the room or to sleep, failing which a fine of Rs. 100/- will be imposed.
- ix) Cooking in the hostels/residents' room is strictly forbidden.
- x) A fine of Rs. 500/- will be charged, if any resident is found using Cooler without prior permission and necessary payment.
- xi) Four wheelers in hostel-premises will not be permitted; however, two wheelers can be used by the hostellers. The University will not responsible for any theft of vehicle.
- xii) Deliveries of any sort (Zomato/Swiggy/Couriers etc.) will not be allowed into hostel premises after the closing time of Abhilasha Women Hostel Complex gate.

OTHER HOSTEL RULES

- i) No residents will be allowed for night stay in other hostel.
- ii) Residents are not allowed to move the items of furniture from their allotted rooms.
- iii) All residents must use Common Rooms and other facilities like T.V., newspapers, magazines, sports items, etc. in proper way. The residents shall be fully responsible for any damage/loss of hostel property. Repair charges for any damage to any item of hostel property shall have to be paid by the resident.
- iv) Residents should be properly dressed while going to the Common Room, Dining Room, Study Room and Hostel Office.
- v) Residents should not keep cash or jewelry or other valuable items in their rooms. The responsibility of safety of the belongings will be entirely that of the residents.
- vi) The hostel authorities will not be responsible for such type of acts in which the resident tries to harm herself purposely.
- vii) Residents who wish to keep their own vehicle (Two wheelers only) must take permission and get the vehicle pass issued from the concerned hostel Warden.

- viii) Residents are required to maintain proper hygienic conditions in washrooms as well as their personal rooms. Dustbin should be used appropriately.
- ix) Loud music is not allowed in the hostel premises.
- x) Residents are not at all allowed to create any type of disturbance/discomfort to fellow residents.
- xi) No resident shall misbehave/indulge in manhandling with any of the hostel workers/fellow residents/hostel staff. Strict disciplinary action, including expulsion from the hostel/University, will be taken against the defaulter.
- xii) All rooms (including almirahs and belongings) are open for inspection by the Chief Warden/ Deputy Chief Warden/ Warden at any time.
- xiii) Any resident found in possession of weapons shall be liable to a fine of Rs. 500/- and or expulsion from the Hostel/University and the matter shall be reported to the police.
- xiv) Unauthorized breaking of locks/windowpanes is strictly prohibited. Defaulters will be fined Rs. 500/-.
- xv) No resident will indulge in any kind of unruly behavior.
- xvi) No resident is allowed to take newspapers/magazines/sports items/equipment in her room without permission of the Warden.
- xvii) No resident shall be involved in stealing any property belonging to fellow hostellers. Strict disciplinary action shall be taken accordingly.
- xviii) All residents are required to clear their Hostel, Mess, Canteen and other dues and obtain a “No Dues Certificate” before they take their examination roll number and again all their dues must be cleared before they vacate the hostel. Before leaving the hostel, every resident shall personally hand over the charge of the room and hostel property to the Supervisor of the hostel. A penalty of Rs. 500/- and other disciplinary action including forfeiture of securities will be imposed on the defaulter.
- xix) No resident is allowed to stand near the main gate of Abhilasha Women hostels complex and nearby areas.
- xx) The residents are not allowed to entertain the guest/guardian in front or near girls’ hostels. For this purpose, the visitors’ rooms of their hostels should be used with permission of the Warden/Supervisor.

- xxi) The residents are not allowed to entertain any lady guest including mother and sisters in their rooms at night, without permission of concerned warden.
- xxii) If a resident comes late without permission, she will be fined Rs. 100/- for 1st time and Rs. 200/- for IInd time. After that she will be expelled from the hostel.
- xxiii) Acts of indiscipline shall be severely dealt with. The Chief Warden/ Deputy Chief Warden will send such a case to the Head of the department concerned for further disciplinary action.
- xxiv) The residents are not allowed to remain out of Hostel premises after the closure of Hostel main gate, except under exceptional circumstances and after obtaining permission of parents/HOD and Chief Warden/ Deputy Chief Warden (Girls). However Hostel Authority will not be responsible in case of any mishappening.
- xxv) If any resident wants to make any representation to the Chief Warden/ Deputy Chief Warden, she should make it through proper channel i.e. through the Warden of the concerned Hostel.

The resident will be barred from applying for hostel admission in future:

- (i) If she sublets the allotted room to any other student/outsider.
- (ii) If any other student is found staying in the allocated room unauthorizedly.
- (iii) Any damage to the property of hostel, the estimated amount will be recovered from the persons /residents involved in the incident.
- (iv) Any clash, assault on co-resident will be seriously dealt in terms of rustication from the University apart from the legal action against such residents.
- (v) No outsider is allowed to enter in any hostel without proper permission.
- (vi) If any resident is found violating any directions and orders of the University repeatedly or on grounds of misconduct during her stay in the hostels she may be expelled/denied hostel accommodation.
- (vii) Indulgence in political activities, anti-National activities, holding of demonstration, pasting of posters in and outside the hostel premises, defacement of walls and involvement in undesirable activities such as misbehavior/ physical assault with Chief Warden/ Deputy Chief Warden/ Warden/Supervisor/ Mess Supervisor /Mess Staff/ Housekeeping staff/ Security Guard or any other officer/official of the University.

Note: If any outsider/unauthorized person is found in a resident's room, the resident shall be liable for expulsion from the hostel with information to parents and a fine of Rs. 2000.

If any resident wants to avail the facility of the appliances from the list given below with the prior permission of the Warden in writing by paying the following charges per month up to 10th of each month for example, Air cooler, Room Heater/Blower/ Halogen Heater (Coil Heater is not allowed), Electric Kettle. If used without permission, a fine of Rs. 1000/- will be imposed.

Note:

- (i) The fees from residents will be charged for entire academic session.

- (ii) In exceptional cases, on the recommendation of the HOD/Director of the respective department/institute/Centre etc., the Chief Warden/Deputy Chief Warden may allow the resident to stay beyond the academic session, on payment of guest charges.
- (iii) The Vice- Chancellor may on the recommendation of the Chief Warden exempt blind students from the payment of all hostel charges.
- (iv) In case a student joins/leaves the hostel in mid-session, she will pay common room, establishment and utensils/furniture charges for entire academic session and not for specific period of her stay in the hostel.
- (v) The hostel fees for Research Scholars/M.Ed. students whose admissions are usually not done along with other PG classes be taken from the month of admission on yearly basis.
- (vi) Hostel Fee is not refundable in any case.

- **RULES FOR WORKING WOMEN**

- (i) The fee charges from the working women will be same as charged from the other hostel residents. Accommodation charges will be deducted only after the assurance of Supdt. Bill for HRA deduction from their salary.
- (ii) All rules and regulations shall remain same as applicable to the Hostel Residents.

- **VISITORS AND GUESTS**

- (i) Visitors are allowed only after making an entry in the Visitors' Register after taking due permission from the Warden.
- (ii) No, visitor, in any case, shall be allowed to meet the resident after the stipulated time.
- (iii) Only those guests shall be allowed to meet a resident whose names are included in the approved guest list submitted at the time of admission.
- (iv) Guests will be allowed to meet the resident only in the Visitor's Room.

- Note:** 1. Rs. 50/- per head, per day shall be charged from the guests and participating teams/individuals whose stay arrangements are made in the hostels on the request of host deptt./office as accommodation charges in advance. The host Deptt./office shall be responsible for the payment.
2. The amount of guest charges shall be deposited in the Registrar Share/Fund.
3. Mess Charges for the guests will be fixed by the Chief Warden from time to time, if necessary.

- **ATTENDANCE AND LEAVE**

- i) No resident is allowed to leave the hostel during night except in emergency. She can go with her parents/relatives whose photos are in the approved guest list by the parents submitted at the time of admission with the permission of the Warden/Supervisor. Any resident found violating this rule will be liable to be expelled from the hostel/University and or fine upto Rs. 100/- will be charged.
- ii) In case if a resident comes late to the hostel (without information/permission) or absents herself in the night from hostel without prior permission, the hostel Warden will immediately inform to the Chief Warden and the parents of such girl student and may take disciplinary action, if required.
- iii) No resident is allowed to leave the hostel during night or early morning except in emergency with the prior permission of the Warden (information to the Chief Warden/Deputy Chief Warden). She can go with her parents/relatives whose photos

are in the approved Guest List.

- iv) In special cases, if the residents are required to leave the station, written prior permission of the Head of the Department/Institute concerned should be submitted to the Warden.
- v) A resident, under all circumstances, shall inform the Warden about her absence from the hostel. She shall sign the register maintained for the purpose at the hostel gate.
- vi) At the time of roll call the residents must show their Hostel-I card to the concerned Hostel Attendant.
- vii) Residents in girls' hostels shall present themselves in person for daily roll-call on the timings notified from time to time. Attendance will be taken by the Warden/Supervisor/Attendant. Defaulters will be marked absent and fined accordingly. Strict disciplinary action, including expulsion from the hostel/University, will be taken against the defaulter.
- viii) The names of the residents absenting themselves without permission for a fortnight or more, may be struck off from the rolls and possession of their rooms will be taken by the Warden.
- ix) The hostel gate will Open at 5.00 a.m. and Close at the time mentioned below:

April 1 st to Sept. 30 th	-	8.00 p.m.
Oct. 1 st to March 31 st	-	7.00 p.m.
Inter Hostel (Summer Time)	-	10.30 p.m.
Inter Hostel (Winter Time)	-	10.00 p.m.
- x) Late entry beyond specified time is not allowed in any case. However, in unforeseen circumstances, the entry may be allowed with the permission of the Warden (information to the Chief Warden) after telephonic discussion with their parents.
- xi) Hostel will be checked by the Warden at night daily and information to the parents' of the students is sent telephonically/text message when they apply for night out leave.

- **HOSTEL MESS :**

- i) Facility of cooperative mess is provided in all hostels. The membership of cooperative mess is compulsory for every resident. Every member will have to give an undertaking that she will shoulder the responsibilities and observe the rules of cooperative mess. Messes are run by the mess committees under the overall control of the Wardens.
- ii) All residents shall have to take food in the hostel. The Mess shall provide only vegetarian foods.
- iii) Those residents who take admission in the month of July will have to pay whole month servant charges.
- iv) **Mess Timings:**

<i>Breakfast</i>	8.00 a.m. to 9.00 a.m.
<i>Lunch</i>	1.00 p.m. to 2.30 p.m.
<i>Dinner</i>	7.30 p.m. to 9.00 p.m.
- v) Meals will not be served before/after the fixed hours.
- vi) Residents are not allowed to enter the cooking area.
- vii) Cooking in the rooms is strictly prohibited.
- viii) Meals will be served in the Dining Room only.
- ix) 23 diets will be compulsory for every resident in a month. If a resident remains on leave during the whole month then a minimum of **7 Diets** (Breakfast, Lunch, Dinner) and servant charges will be charged for that period. If resident coming from the home and mark the attendance at night, the mess will be considered open from that time onwards.
- x) In case of illness the names of sick residents will be registered with the Supervisor to get the special light food cooked for them.
- xi) A register for on/off this will be available on the mess counter wherein the residents should enter the information about missing the meals so as to avoid wastage of food.
- xii) Mess charges will be paid by the 15th of each month. After this date a fine of Rs. 5/- per day will be charged upto 20th of each month and the resident will not be allowed to take meals thereafter. The fine for delay pertaining to hostel dues will also be charged on the same pattern as mess dues.
- xiii) If the total amount of mess dues of a resident exceeds the security deposited on the 20th of each month, she will not be eligible for mess services from 21st onwards.

- xiv) All complaints requiring immediate attention of the Warden should be made in writing through a member of Mess Committee.
- xv) The Chief Warden may expel a resident from the hostel, if any kind of dues to be paid by her remains unpaid for two consecutive months.
- xvi) All hostel and mess payments are to be made by cheque after verification by the hostel warden and Mess Committee and cash transactions are prohibited, all cash receipts are to be deposited in the bank within 24 hours. Hostel staff dealing with mess transactions found in possession of cash illegally, disciplinary action will be taken against her.

Mess Servant Charges

Rs. 550/- per student, per month will be charged as *Mess Servant Charges*.

N. B.:

Hostels will be closed during Diwali and Holi vacations.

Responsibilities of the Residents

- i) Living in hostel pre-supposes a high degree of integrity and conscientiousness as a member of community. It also entails a moral responsibility on a resident.
- ii) No damage should be done to hostel property.
- iii) Make every effort for peaceful co-existence and maintaining discipline and decorum.
- iv) Observe all hostel rules meticulously in letter and spirit.

Note:

- i) The Hostel Authorities may expel any resident at any time, if they are not satisfied with her health such as chronic disease or conduct.
- ii) Any resident found violating these rules will be liable to be expelled from the hostel/University and /or fine upto Rs. 500/-
- iii) Any other notification from time to time by the Chief Warden/ Dy. Chief Warden will be binding on the residents.
- iv) Hostel rules can be changed at any time with the approval of Vice-Chancellor.
- v) The University authorities will have the right to get the hostel vacated or closed as and when they feel the situation so warrants.

- **Prohibition of Ragging**

The instruction for curbing ragging as conveyed by the UGC vide letter No. 1-15/2009

(ARC) pt. III dated 17th March, 2017, in view of the judgement of Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009 and also given in chapter X be adhered to strictly (UGC Regulations on Curbing the Menace of Ragging in Higher Education Institutions, 2009, UGC website: www.ugc.ac.in & the Haryana Prohibition of Ragging in Educational Institution Ordinance 2012.

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately. The punishment may include expulsion/suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding or withdrawing scholarships or fellowships and other benefits (ii) forfeiting campus placement opportunities or recommendations. (iii) debarring from appearing in any test or examination or other evaluation process (iv) debarring from representing the educational institution in any regional, national or international meet, tournament, youth festival, etc. (v) withholding results (vi) suspension or expulsion from hostel or mess (vii) cancellation of admission (viii) lodging of FIR with the local police. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness to any other students, indulging in rowdy or indiscipline activities which cause or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in freshers or junior students or any type of abuse through electronic media or wrongful confinement, use of criminal force, assault as well as sexual offence, trespass, defamation or threat to defame will be deemed an act of ragging.

Hon'ble Supreme Court of India in SLP (C) No. 24295/2004 in the matter of University of Kerala V/S Council of Principals, Colleges of Kerala and others has ordered that if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institution.
