It is to inform you that on the basis of Inspection report submitted by the Inspection Committee which visited your college on 12.03.2023 to see the infrastructure facilities provided by your college, the Vice-Chancellor, **in anticipation approval of the Academic/Executive Council**, has been pleased to grant provisional 'Associate Status' to a new established Ekta College of Sanskrit, Gohana, Sonapat for starting Shastri Course with an intake of 80 seats (one unit) , w.e.f the session 2023-24 with the condition that your college shall make full compliance of all the observations/shortcomings/ deficiencies pointed out by the Inspection Committee in its report, at the earliest (copy enclosed). In addition to, you shall also fulfill/observe the following Conditions:-

1. Sanctioned intake in each course should not exceed.
2. Observance of University Act, Statues, Ordinances, Rules and Regulations and other instructions issued by the University from time to time.
3. In the event of non-compliance of these deficiencies and other University guidelines/Instructions, the University will be free to withdraw the Associate status and all the liabilities arising out of withdrawal of the said status solely be of the concerned trust/institute.
4. Students teachers ratio should be maintained strictly.

You are also required to submit a request along with extension fee for the second year courses as per fee structure and schedule prescribed by the University in the Fee Structure, failing which admission, if any made, shall not be allowed.
