Sub: Follow up action on Reso. No. 21(5) of the Executive Council meeting dated on 30.10.2023 regarding providing the syllabus of Computer Application/Computer Science subject in B.A programme.

Madam,

Kindly refer to your office letter No. GCG/2023/845-848 dated 11/10/2023 on the subject cited above.

In continuation to this office letter No CB-1/2023/24468 dated 9.10.2023 vide which provisional affiliation was withdrawn of the subject of computer science due to non availability of computer science syllabus for B.A.-I,II and III in the University. On the request of your College, a committee was constituted by the Vice-Chancellor in this regard. The committee recommended that keeping in view the request of the Principal, Govt. College, Ganaur, Sonapat the University may as a special case, allow offering of Computer Science (Semesters 1 to 6) as an elective subject as per syllabus of B.Sc. program to the students enrolled in B.A only for the present batch (2023-24) in Govt. College Gannaur as a one time measure only. The necessary changes in marks in the Scheme of Examination may be carried out in line with the scheme of examination for B.A Program. This provision may not be treated as precedence in future. The Vice-Chancellor ordered to refer the recommendations of the Committee to the Academic/Executive Council for consideration.

The Academic Council vide Reso No. 10 dated 20.10.2023 has considered the recommendations of the Committee and recommended for placing before the Executive Council for consideration and approval. The Executive Council vide Reso No. 21(5) dated 30.10.2023 has approved the recommendations of the Academic Council. A Copy each of Resolutions of the A.C/E.C. are enclosed herewith for your kind information and necessary action.
