1. Considered the requests received from various students for admission to intermediate semesters (3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> and 9<sup>th</sup> semesters) in the UTDs/Colleges/ Institutes for the session 2023-24.

**RESOLVED THAT KEEPING IN VIEW OF THE STUDENT'S CAREER, THE LAST DATE FOR ADMISSION TO INTERMEDIATE SEMESTERS IN THE UTDs / INSTITUTES (INCLUDING MDU-CPAS, GURUGRAM) AND THE COLLEGES/ INSTITUTES AFFILIATED TO M.D. UNIVERSITY, ROTHAK FOR THE UG/ PG PROGRAMS (EXCEPT WHERE THE ADMISSIONS ARE MADE THROUGH STATE / CENTRAL AGENCIES VIZ.; AICTE, HSTES, NCTE, BCI, PCI, COUNCIL OF ARCHITECTURE ETC.) BE EXTENDED UPTO 30.09.2023 WITH A LATE FEE OF RS. 5000/- (TO BE REMITTED TO THE UNIVERSITY ALONGWITH CONTINUATION RETURN) PER STUDENT. NO FURTHER EXTENSION WILL BE GRANTED BEYOND 30.09.2023.**

**THE HEAD / DIRECTOR / PRINCIPAL OF THE CONCERNED DEPARTMENT / COLLEGE/ INSTITUTE SHALL ARRANGE EXTRA CLASSES FOR SUCH ADMITTED STUDENTS TO ENSURE THE MINIMUM REQUIREMENT OF TEACHING DAYS.**

2. Considered the request made by the Law/Engineering/Management Colleges/Institutes affiliated to MDU, Rohtak for extension in admission schedule for admission to 1<sup>st</sup> semester in the Programs as the seats still lying vacant.

**RESOLVED THAT THE LAST DATE FOR ADMISSION TO FIRST SEMESTER IN THE LAW/ENGINEERING/MANAGEMENT COLLEGES/ INSTITUTES AFFILIATED TO M.D. UNIVERSITY, ROTHAK FOR THE UG/ PG PROGRAMS (EXCEPT WHERE THE ADMISSIONS ARE MADE THROUGH STATE / CENTRAL AGENCIES VIZ., AICTE, HSTES, NCTE, BCI, PCI, COUCIL OF ARCHITECTURE ETC.) BE INCREASED UPTO 30.09.2023. NO FURTHER EXTENSION WILL BE GRANTED BEYOND 30.09.2023.**

**FURTHER RESOLVED THAT THE ADMISSIONS TO THE UG/PG PROGRAMS ON THE VACANT SEATS (INCLUDING SUPERNUMARY CATEGORY), IF ANY,**
