New Delhi: Sandeep's parents were extremely protective of him. He was the only child, born 14 years after his parents' marriage. On Jan 28, the 12-year-old went missing from near his home in Mumbai's Wadala. The family approached police but they couldn't trace him, leaving Sandeep's father, a 49-year-old fisherman and his 42-year-old mother devastated. They began the day visiting the police station and ended it after scouring the local hospitals and the neighbourhood.

On March 4, the parents' search ended when the cops discovered a decapitated and severely decomposed body in a forested area. The last glimmer of hope was extinguished the following day when the skull was recovered. Also, by then, the cops had a suspect. A man identified as Bipul Shikari was captured on CCTV with Sandeep. He was seen making the kid sit in a taxi.

When the news of the suspect and the police pursuit spread, the residents of Shikari's neighbourhood caught the man and informed the police. Covered in mud and
