The Schedule of late receipt of Documents/Migration Certificate of OTMIL Courses for the session of 2023-2024.

Sir/Madam,

It is hereby notified that the schedule for late receipt of submission of hardcopy of documents shall be charged with late fee prescribed as under:-

- 1. i) For 1-30 days late after the expiry of due date: Rs. 500/- per student
 - ii) For 31-45 days late after the expiry of due date: Rs. 1000/- per student
 - iii) For 46-60 days late after the expiry of due date: Rs. 2000/- per student
 - iv) For one week before commencement of examination Rs. 3000/- with the permission
 - of Vice-Chancellor and after that no request will be considered under any circumstances.
- 2. The schedule of submission of Migration Certificate alongwith late fees shall be as under:-

OTMIL Programe

Upto 30 th May 2024	with late fees of Rs. 500/-
Upto 30 th July 2024	with late fees of Rs. 1000/-
Upto 31st Oct., 2024	with late fees of Rs. 2000/-

If Migration Certificates received after the above mentioned scheduled penal will not be accepted in any case and the candidature will stand automatically cancelled.

- 3. In case an institute fails to submit the Registration Return-cum-Examination form and continuation return within prescribed time limit (without late fees), the same will be accepted with late fee @2/- per day per student in respect of each kind of fee including examination fee (total @ Rs. 20/- per day per student) for first 7 days and after this @ 65/- per student per day i.e. (Rs. 5*9 = 45+ Rs. 20 examination fee) shall be charged in respect of each kind of fee separately as already provided in Ordinance before one month of the commencement of examination of a Program.
- 4. Thereafter, the Registration Return-cum-Examination Form with late fee as referred above will be accepted before ten days of the commencement of examination with the approval of the Vice-Chancellor.

In case of student who are already registered with the University, the registration number shall be indicated in Registration Return, but such a student shall pay the prescribed continuation fee.
