NOTIFICATION

In continuation of this office Notification No. MDU/R-1/AE-1/2024/2590 dated 03.05.2024, Corrigendum issued vide Endst. No. MDU/R-1/AE-1/2024/3575 dated 04.06.2024 and in continuation of Notification issued vide Endst. No. MDU/R-1/AE-1/2024/13080 dated 22.06.2024, it is notified for information of all concerned that the last date, for submission of online Examination Form for Special Chance as per notification available at University website www.mdu.ac.in, is further extended upto 10.07.2024 which was earlier 05.07.2024. The other conditions as contained in Notification No. MDU/R-1/AE-1/2024/2590 dated 03.05.2024, Corrigendum issued vide Endst. No. MDU/R-1/AE-1/2024/3575 dated 04.06.2024 and earlier Notification No. MDU/R-1/AE-1/2024/13080 dated 22.06.2024 shall remain unchanged.

The cases who got registered prior to 2001 were also considered by a committee. As per recommendations of the committee, such candidates may also apply subject to the following conditions:

- 1. The scheme and syllabi of examinations will remain the same as that was prescribed in 2001 for all the candidates registered before 2001 and they shall not claim for nomenclature/syllabus according to their registration year.
- 2. The applicant must ensure himself/herself before applying for special chance regarding nomenclature of the paper he/she is willing to reappear/improve as it should be same as that prescribed in Scheme of Examinations 2001. For this, they will also be required to submit an undertaking at the time of filling exam forms. All such candidates shall apply for special chance and appear for exam on his/her own risk. No objection will be entertained regarding nomenclature, whatsoever, and the fee once paid shall not be refundable.
- 3. All the applicants having the registration/enrolled in the year before 2001 may apply for special chance upto 10.07.2024 subject to the above conditions.

- 4. The last date for applying for special chance may be extended upto 10.07.2024.
- 5. All such applicants may be allowed the special chance, as per the prescribed fee, already notified.
