MINUTES OF THE MEETING OF THE STANDING GRIEVANCE REDRESSAL COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 05.07.2024 AT 03:00 P.M. IN THE COMMITTEE ROOM ADJACENT TO THE OFFICE OF REGISTRAR REGARDING GRIEVANCES OF ISSUES RELATING TO ADMISSIONS IN VARIOUS PROGRAMS 2024-25.

The Committee considered the various issues/ Grievances / requests received from the candidates relating to admission to UG Programs 2024-25 and after detailed deliberations, the Committee resolved as under:

1. Regarding issue of considering the production of original DMC of 10+2, the Committee resolved that in case of original DMC is not available with the applicant; he/she may submit the down-loaded result from the Net, duly certified by the Headmaster/Principal of the concerned School. However, he/she is required to submit the original DMC/10+2 Certificate within next 07 (seven) days failing his/her admission shall be treated as **CANCELLED**.
2. Regarding issue of change of category, the Committee resolved that change in category may be allowed after 3rd Counselling. If the seat(s) remains) vacant after 3rd Counselling in any category, the requests forwarded from Academic Branch and also received on the spot in the Department, if any, regarding the change of category be considered and forwarded to UCC for the change of category after carefully verifying the relevant documents. After the change of category, the seats remaining vacant should be first filled category-wise as per merit of the entrance test on 4th Counselling and after that the seats still remain vacant be converted to open category on the same date and to be filled up as per the guidelines available in the Prospectus for the session 2024-25. However, those candidates who have applied against AIO seats but fulfill the conditions of being Haryana resident as per Appendix-A given in the Prospectus, they may be considered against HOGC category from 2nd Counselling onwards.

3. At Sr.No.11, the issue is regarding correction in name, as the candidate inadvertently wrote the name of father in the column of his name. The committee resolved that the request of the candidate may be acceded to and he may be considered for admission from 2nd Counselling onwards.
4. As there is no provision of relaxation in processing fee for EWS category, therefore, the committee resolved that the request of the candidate at Sr.No.36 (Mr. Krishan Singh) may not be acceded to.
5. Regarding request made by Mr. Sohil (Sr. No.37) for allowing him to update the BC-A Certificate, the committee resolved that he may be considered for admission from 2nd Counselling onwards if he produces the BC-A Certificate as per the requirement.
