1.	B.Ed 1st Year (Regular & Re-appear)	20.07.2024 to 11.08.2024
2.	The Practical Examinations of such B.Ed 1 <sup>st</sup> Year (Only Re-appear) students of those Colleges which have now been affiliated to Gurugram, University, Gurugram. <b>The practical examinations of such students will be conducted at Deptt. of Education, M.D.University, Rohtak. Their specific schedule within the above schedule will be notified separately.</b>	

- (1) The appointment of the Practical Examiners shall be made by the University.
- (2) IT IS MANDATORY FOR THE COLLEGES TO CONDUCT VIDEOGRAPHY AND THAT TOO AT THEIR OWN LEVEL ( EXPENDITURE FOR THE SAME WILL BE BORNE BY THE CONCERNED COLLEGE/INSTITUTE ITSELF).
- (3) The Practical Examinations shall be conducted judiciously as per above schedule and after conducting the Practical Examinations, the concerned colleges shall be required to upload the marks awarded by the Examiner(s) on the University portal **latest by 19.08.2024.**
- (4) The College concerned shall also be required to submit Original forwarding memo along with Manual Practical Awards complete in all respects( i.e. - having details of total Present and absent students, full signature and complete address of the Practical External Examiners with contact No., Beneficiary ID) along with soft copy of the videography done to the Asstt.Registrar(Conduct),M.D. University,Rohtak, within seven days after uploading the External Practical Awards **latest by 26.08.2024**, failing which late fee will be charged from the College concerned as per University Rules irrespective of the submission of original external awards in time.
- (5) While submitting TA/DA Bills, the Practical Examiner must be required to clearly mention their full name, designation with Grade Pay, Beneficiary ID, Name of College, Name of Course with Semester and Session and same may be submitted directly to the Accounts Branch of the University.

#### Important Notes:-

- (i) **The actual date of practical examinations within the above schedule will be notified by the Colleges to their respective regular/re-appear students, under intimation to this office.**
- (ii) **The Practical Examinations of Re-appear students of Colleges affiliated to this University shall be conducted in their respective Colleges of which they are/were regular students.**
