

27. To ratify the action taken by the Vice-Chancellor in approving the recommendations of the Fee Structure Committee meetings dated 14.03.2024, 21.05.2024, 28.05.2024, 11.06.2024 & 21.06.2024.

The meetings of the Fee Structure Committee (FSC) were held on 14.03.2024, 21.05.2024, 28.05.2024, 11.06.2024 & 21.06.2024 to consider various issues.

A. Fee Structure Committee meeting dated 14.03.2024.

Considerations:-

- 1- To address of various requests /issues received from the students across various disciplines.
- 2- The recommendations given by the Sub-Committee in its meeting held on 04.03.2024 (Annexure A/140A Page 1404, already circulated).
- 3- Proposal of HoD (History & Archaeology) regarding revision/updating of Admission Fee Structure of M.A. History Program (Annexure A/141 Page 1405, already circulated).

Recommendations (Annexure A/142 Page 1406-1407, already circulated)

- 1(a) After detailed deliberations, the committee resolved that increase in annual fee of 10% in two Sub-Heads i.e. Tuition Fee and Development fee may be kept only for the newly admitted students. However, in the subsequent years of entire duration of the program, the student shall pay the same Tuition and Development Fee as charged in the first year.
- b) The Committee considered and resolved that the request of the Students regarding conversion of SFS Program into Budgeted Program may be sent to the DHE Govt. of Haryana for consideration and further necessary action as the matter relates to the financial support to be provided by the State Government.
- c) Keeping in view the rising inflation and comparative cost analysis of the Ph.D. Fee Structure Ph.D Fee Structure of different State universities in the Haryana State, it would not be prudent to recommend deduction/ reduction of fees unless financial support from the State Government is received in this regard. The Committee further, noted that even with the existing Fee Structure, it is difficult to maintain the quality infrastructure, world class research facilities with sophisticated equipments in labs, availability of resources and quality journals in the library for utilization by the students.
2. The Committee discussed the recommendations given by the Sub-Committee in its meeting held on 04.03.2024 with regard to examine the fee concession being given to the employees and their wards in Distance Learning Programs and found the same in order. The committee resolved that the same may be recommended for approval.
3. The Committee considered and resolved that the proposal of the HOD (History & Archaeology) regarding revision/updation of Admission Fee Structure of M.A. History Program w.e.f. the session 2024-25 may be deferred to the next meeting.

The above recommendations were approved by the Vice-Chancellor and accordingly the notification was issued.

B. Fee Structure Committee meeting dated 21.05.2024.

Considerations:-

- 1- Fee Structure for the new UG 4-Year Programs and 5-Year Integrated Programs to be offered in the 2024-25.
- 2- Change in Fee Structure.
- 3- Fee Waiver.



**Recommendations (Annexure A/143 Pages 1408-1409, already circulated):-**

- 1- The Committee deliberated over the agenda and proposed Fee Structure for the new UG 4-Year Programs and 5-Year Integrated Programs (Annexure-I)
- 2- The Fee Structure shall remain the same for entire duration of the Program except the charges for Examination, RR/CR etc. as per University rules.
- 3- The Committee recommends that 100% and 50% fee waiver in tuition fee may be admissible for the students who have family income upto Rs.1.80 Lac and Rs.3.0 Lac respectively). For claiming the same, the student has to submit Family ID (Parivar Pehchan Patra) as issued by the State Govt. or latest Income Certificate issued on or after 01.04.2024, wherever applicable.

The above recommendations were approved by the Vice-Chancellor and accordingly the notification was issued. However, the University received representations from various students' groups regarding issue of the fee fixed by the University for 4-Year UG Programs. The Vice-Chancellor constituted a Committee to consider these representations and hear representatives of various students' groups.

The Committee considered various representations received from the different student's groups in its meeting dated 21.06.2024. The Committee also kept in view the deliberations in the online meeting under the chairmanship of DGHE & TE, Haryana on 13.06.2024 as well as the meetings of Vice-Chancellor's conveyed by ACS, Higher Education on 19.06.2024. The Committee accordingly revised the fee structure of various programmes in consonance with the direction emanating from the aforementioned meetings. After deliberations the revised fee structure has been proposed as at Annexure A/144 Pages 1410-1411, already circulated).

The above recommendations were approved by the Vice-Chancellor and the revised Fee Structure was notified.

**C. The Fee Structure Committee meeting dated 28.05.2024**

**Considerations**

The Fee Structure for International Students.

**Recommendations (Annexure A/145 Pages 1412-1417, already circulated):-**

- 1- In order to promote diversity and inclusivity, the Fee Structure of International students shall be at par with the domestic students (placed at Table-1).
- 2- For PG Programs, the Fee Structure for International students is placed at Table-2.
- 3- For International students availing hostel facility, the Fee Structure is placed at Table-3.
- 4- The Committee further resolved that:-
  - i) 50% concession/waiver in tuition fee may be given to those international students who have secured 90% or more marks or grade equivalent there to in qualifying examination.

- ii) 25% concession/waiver in tuition fee may be given to those international students who have secured 75% or more marks or grade equivalent there to in qualifying examination.
- iii) One time Rs.5000/- will charged as Admission Processing Fee from International students by the university.

The above recommendations were approved by the Vice-Chancellor and the Fee Structure was notified.

Further, the Committee resolved that the same may be submitted to the Vice-Chancellor for consideration and approval.

A meeting of the Fee Structure Committee was held on 28.05.2024 at 03.00 p.m. in the O/o Dean Academic Affairs, M.D. University, Rohtak to consider the Fee Structure of UG & PG Programs of UTDs for the International Students, session 2024-25.

The Fee Structure of UG & PG Programs offered for International Students was deliberated upon at length. It was resolved that:-

- 1- In order to promote diversity and inclusivity, the Fee Structure of <sup>UG</sup> ~~for~~ International students shall be at par with the domestic students (placed at Table-1).
- 2- For PG Programs, the Fee Structure for International students is placed at Table-2.
- 3- For International students availing hostel facility, the Fee Structure is placed at Table-3.
- 4- The Committee further resolved that:-
  - i) 50% concession/waiver in tuition fee may be given to those international students who have secured 90% or more marks or grade equivalent there to in qualifying examination.
  - ii) 25% concession/waiver in tuition fee may be given to those international students who have secured 75% or more marks or grade equivalent there to in qualifying examination.
  - iii) One time Rs.5000/- will be charged as Admission Processing Fee from International students by the university.


The recommendations of the Committee may be submitted to the Vice-Chancellor for consideration and approval.





1. Each student shall deposit ₹500/- (refundable security) at the time of admission to 1<sup>st</sup> Semester.
2. As per orders of the Vice-Chancellor conveyed by the R&S Branch vide Letter No.R&S/R-2//2024/500 dated 19.01.2024, the amount pertaining to the Insurance i.e. Rs.48 per student shall be non-refundable at any time, irrespective of whether he/she continues be on the roll of the University or withdraws his/her admission.
3. One time ₹5000/- may be charged as admission processing fee.
4. 50% concession/waiver in tuition fee may be given to those international students who have secured 90% or more marks or grade equivalent there to in qualifying examination.
5. 25% concession/waiver in tuition fee may be given to those international students who have secured 75% or more marks or grade equivalent there to in qualifying examination.

The admitted student of each Program shall be required to deposit 50% of the total fee of the Program at the time of admission and remaining 50% up to 31<sup>st</sup> January. The delay in payment of the fee shall be dealt as per MD University rules.

The meeting was held to discuss the Fee Structure for PG Programs 2024-25 including the following new PG Programs:-



**Note:**

The Executive Council vide Resolution No. 8 in its meeting held on 4.9.2019 as approved that all the students of UTDs will be provided a Group Insurance of Rs. 1,00,000 to each enrolled student from the session 2020-21. The total premium payable will be Rs. 96 (Rs. 48 student share & Rs. 48 University share). In case of SC students who are exempted from fee, they will pay their shares along with library security and insurance charges (Rs.48/-) at the time of admission. Further, as per the letter of the Superintendent (R&S) conveyed vide letter No.R&S/R-2/2024/500 dated 19.01.2024 that the amount pertaining to the Insurance i.e. Rs.48 per student will be non-refundable at any time, irrespective of whether he/she continues to be on the roll of the University or withdraws his/her admission.
