The PG Board of Studies in Mathematics in its meeting held on 01.06.2024 considered the recommendations of the Departmental Committee meeting held on 01.06.2024 and resolved that the Program M.Sc. Mathematics with Computer Science under SFS be suspended w.e.f. the session 2024-25 and in lieu of this suspension, one more unit (60 Seats) may be added to the already running M.Sc. Mathematics Program under Self-Financing Scheme.

The Dean Faculty of Physical Sciences was requested to hold an emergent of the Faculty of Physical Sciences for consideration the recommendation of the PG Board of Studies in Mathematics on which, the Dean Faculty of Physical Sciences has offered his comments that the Program M.Sc. Mathematics with Computer Science is only suspended/discontinued by the Department through PGBOS along-with the proposal to increase the seats in M.Sc. Mathematics under SFS w.e.f. the session 2024-25. He stated that keeping in view the urgency of the case, the only viable solution is to seek the approval of the Vice-Chancellor.

The Vice-Chancellor has approved the proposal U/s 9A(5) of MDU Act and passed orders to report the matter in the forthcoming meeting of the Faculty of Physical Sciences.







✓ In lieu of this suspension, one more unit (60 seats) may be added to the already running M.Sc. Mathematics programme under the Self Financing Scheme.


