**NOTIFICATION**

It is notified for all concerned that keeping in view of the ongoing admission process to UG Programmes under NEP-2020, on the recommendations of the Committee, the Vice-Chancellor, in anticipation of the approval of the Academic Council, has approved the following resolutions of the meeting of the Committee held on 02.06.2024:

1. The existing 3-year UG Programme in affiliated colleges stands extended for 4-year UG Programme as per NEP-2020, and the college(s) shall be required to create suitable infrastructure and other resources for the 4<sup>th</sup> year in due course of time.
2. The existing 3-year Honours Programme wherever granted also stands extended to 4-year Honours in single major programme in the concerned discipline.
3. The Nomenclature of existing B.Sc. (Medical) and B.Sc. (Non-medical) shall be as under:
  - (i) B.Sc. (Medical) - B.Sc. (Life Sciences)
  - (ii) B.Sc. (Non-Medical) - B.Sc. (Physical Sciences)
4. In case of colleges already affiliated for different programmes in a single stream e.g. in case of commerce affiliated for B.Com (Pass course), B.Com (Vocational), B.Com (with Computer Sciences) etc. shall now be offering B.Com (Hons, / Hons. with research) as per provisions under NEP-2020. However, a student enrolling in B.Com (Hons. / Hons. with research) may exercise options regarding minor course(s) and vocational course(s) based upon which B.Com (Vocational) OR B.Com (Computer Sciences) shall be reflected in the mark-sheet of an individual student. Accordingly, the intake in such a case shall be calculated as under i.e.



(i) One Unit of B.Com = 80 students	Three units of B.Com 4 year UG Programme = 240 students
(ii) One Unit of B.Com (Vocational) = 80 students	
(iii) One Unit of B.Com (Computer Sciences) = 80 students
