Sub: Final seniority list of Assistants of PWD category for grant of benefit of reservation in promotion to PWD employees w.e.f. 01.01.1996 in terms of State Government instructions and orders of the Hon'ble High Court in CWP No. 15408 of 2022.

Sir/Madam,

In terms of State Government instructions issued vide Memo No. 22/59/2020-1GS-III dated 25.03.2022 prescribing three (03) percent horizontal reservation in case of promotion to Group A, B, C, and D posts for persons with benchmark disabilities with effect from 01.01.1996 to 18.04.2017, and four (04) percent reservation w.e.f. 19.04.2017 for granting reservation in promotion to PWD employees, this office had circulated a provisional seniority list of Assistants of PWD category vide letter No. EN-8/2022/7518-34 dated 11.07.2022 for promotion on the post of Deputy Superintendent, Superintendent, Assistant Registrar and Deputy Registrar, and invited objections from all concerned employees. The same was challenged in the Hon'ble High Court, Chandigarh in CWP No.15408 of 2022 and the Hon'ble Court had imposed stay on said provisional seniority list circulated vide letter dated 11.07.2022. Further, the Hon'ble High Court has decided the case vide its orders passed on 11.07.2024 and set aside the provisional seniority list circulated vide letter dated 11.7.2022, and also ordered to frame seniority list of Assistants afresh by treating the petitioner (i.e. Sh. Shyam Sunder) senior to private respondents as on 01.01.1996, in accordance with law.

Accordingly, the office has revised the provisional seniority list vide letter No. EN-8/2024/M-57/8489-8505 dated 10.09.2024 and invited objections from all concerned. The objections received from all concerned within stipulated time have been dealt by this office and a final seniority list of Assistants of PWD category have been prepared for promotion on the post of Deputy Superintendent, Superintendent, Assistant Registrar and Deputy Registrar, as under:-


