

There is no bar even if they are receiving any other scholarship. The applications may be screened at your own level and recommended number **should not exceed 5% of the seats per course per class.**

Further, The payment of scholarship shall be transferred in the bank account of the concerned students. The names of the Need-cum-Merit Scholarship students should reach in the office of the undersigned upto **15th Nov, 2024** in the enclosed proforma.
