Sir/Madam,

You are aware that in response to your request dated 26.07.2023, the Vice-Chancellor, in anticipation approval of Academic/Executive Council was granted time upto 30.06.2024 for submission of NOC from the central body i.e. NCTE for shifting of premises to new location i.e. #1628/4, Rajindera Colony, Bhiwani Chungi, Rohtak and also allowed to put your College under Admission Category for the session 2023-24. In response to the said letter, you also submitted the Bank Guarantee of Rs. 5,00,000/- (Five Lacs only) and an affidavit to the effect that if your College fails to submit the NOC from the NCTE regarding shifting of premises to its new location i.e. #1628/4, Rajindera Colony, Bhiwani Chungi, Rohtak, then the Performance Bank Guarantee of Rs. 5,00,000/- be encashed and forfeited and thereafter the process of disaffiliation may be initiated against the College without any further notice.

As you have failed to submit the permission of the Apex Body i.e. N.C.T.E., New Delhi regarding shifting of premises to new location of your College i.e. #1628/4, Rajindera Colony, Bhiwani Chungi, Rohtak to the University upto the stipulated period i.e. 30.06.2024, hence, the matter has been considered by the Vice-Chancellor and in terms of orders passed, your College i.e. Sunil Gugnani Memorial College of Education for Girls is placed in 'No Admission Category' for the session 2024-25. Further, the process for disaffiliation is also being initiated against your College.
