Sub: Status of Sunil Gugnani Memorial College of Education for Girls, 1628/4, Rajindera Colony, Bhiwani Chungi, Rohtak as 'No Admission Category' for the session 2025-26

Sir/Madam,

It is again reiterated that from the session 2008-09, you had to submit the approval of shifting of the building from the NCTE as the same is mandatory to run the College. Necessary directions/advisories to submit the NCTE approval were also issued by the University from time to time. Provisional Affiliation granted from year to year basis was extended on the undertaking/requests submitted by the you to meet out the requirement of permission shortly. As per clause No. 8(11) of the Apex/Central body i.e. NCTE Notification dated 27.11.2007, it has been specified that "In case of change of premises, prior approval of the Regional Committee concerned shall be necessary which may be accorded after due inspection of the institution at the new site", whereas you have not submitted the same in this regard, so far.

Besides above, as per point No. 4.1 of the Ordinance 1: Procedure for granting affiliation to Colleges/Institutions, "The Govt./Society/Trust which proposes to start the College and to get it affiliated to the University shall submit an application to the Dean Colleges Development Council alongwith No Objection Certificate/permission letter from the concerned department of the State Govt. and the Central Regulatory Body and other relevant documents as provide in Clause-3 and in the Statute/ordinance prescribed for the same within the stipulated period with requisite fee and shall satisfy the University that it fulfills all the conditions prescribed for affiliation by the Act, the statutes, the ordinances, the regulations and the instructions issued by the University from time to time.

Lately, a financial bank guarantee was submitted by you in this regard alongwith affidavit dated 18.08.2023 to the effect that if the College fails to submit the NOC from the NCTE regarding shifting of premises to its new location upto 30.06.2024, then the bank guarantee of Rs. 5.00 lacs will be forfeited and encashed and thereafter the process of disaffiliation may be initiated against the College without any further notice. As per E.C. Reso. No. 18(26) dated 26.06.2024, you were required to submit the permission from the Apex body i.e. NCTE to the University upto 30.06.2024. But due to non-submission of NOC/shifting permission from the NCTE within stipulated period, in terms of above E.C.Resolution, the bank guarantee was forfeited and as such your College was also put in 'No Admission Category for the session 2024-25. It is also clarified that the permission/

shifting orders are being issued by the NCTE for example the University has received permission/shifting orders in respect of 02 other Colleges i.e. I.P.S. College of Education Research and Technology, Nehru Colony, Rohtak and Kirti College of Education, Village Anayat, Tehsil Gohana, Distt. Sonapat.

Further, vide this office letter No. CB-IX/2025/9074 dated 04.07.2025, you were again asked to submit the requisite permission of the NCTE regarding shifting of premises within a week otherwise your College will be placed in 'No Admission Category' for the session 2025-26. As you have also failed to submit the requisite permission of the NCTE, New Delhi, so far, therefore, the matter has been considered by the Vice-Chancellor and in terms of orders passed, your College i.e. Sunil Gugnani Memorial College of Education for Girls has been placed in 'No Admission Category' for the session 2025-26 and the status of College w.r.t. admission to B.Ed. program is subject to the final outcome of the Court case in the Hon'ble Pb. & Hry. High Court at Chandigarh.
