  - iii) ALL THE SPORTS ACTIVITIES AS SCHEDULED IN THE SPORTS CALENDAR OF AIU, NEW DELHI AND THE INTER UNIVERSITY GAMES 2017-18 SHALL BE HELD AS USUAL.
  - iv) WHEREAS POSSIBLE, THE EXPENDITURES MAY BE CURTAILED WHILE ORGANIZING THE SPORTS ACTIVITIES ON THE UNIVERSITY CAMPUS.
  - V) IT WAS NOTED THAT THE INCOME OF THE SPORTS OFFICE HAS BEEN DECREASED DUE TO SHIFTING OF THE COLLEGES / INSTITUTES WITH THE OTHER UNIVERSITIES OF THE STATE.
