22. Consideration of the recommendations of the Fee Structure Committee in its meeting held on 21.07.2025 regarding Fee Structure of various Open and Distance Learning Programs and Online Programs through Centre for Distance and Online Education for the session 2025-26 (Annexure A/27 page 116, already circulated).

A meeting of the Fee Structure Committee was held on 21.07.2025 regarding Fee Structure of various Open and Distance Learning Programs and Online Programs through Centre for Distance and Online Education for the session 2025-26. The Committee considered the Fee Structure of the following programs and recommended as under:

i) MBA (Business Psychology) Program (ODL Mode):

Tuition/ Student Support Services Fee	Self Learning Material	Other Charges	Alumni Membership Fee	Total Fee Per annum	Annual Fee for : i) SC/ST Category of Haryana Only ii) Working defence personnel upto level of JCO (receiving no financial aid)	Annual Fee for MDU Employees/ Ward/Spouse

It is also recommended that 5% of Total Fee may be increased for new batch every year like other ODL programmes.

ii) UG/PG Programs being run through Online Mode:

Keeping in view the lower strength of students due to 10% increase in the fee for the online programs in last academic session, it is recommended that for the session 2025-26, the 10% increase in fee may not be done i.e. the fee which was charged for the session 2024-25 may be charged from the newly admitted students for the session 2025-26 for the UG/PG programs being offered through online mode.

iii) New Courses: Certificate Courses

The fee for new courses 'Certificate Course in Food Truck Operations' to be offered through ODL and OL mode and the 'Certificate Course in Professional Skills' to be offered through Online Mode may be prescribed as ₹ 3000/-. The Committee also recommends that there shall be an increase of 5% and 10% in the fee annually for the Certificate courses to be offered through ODL and OL mode, respectively.

The Vice-Chancellor has approved the Minutes of the meeting of Fee Structure Committee dated 21.07.2025 and referred the same to the Executive Council for its consideration and approval.

The Executive Council may consider the recommendations of the Fee Structure Committee of its meeting held on 21.07.2025.
