The President Sports Executive Board welcomed all the present members. Thereafter, the agenda items were taken up one by one for discussion and following resolutions were made on various items in the meeting:

- 1. **RESOLVED** to confirm the minutes of the last meeting of the Sports Executive Board held on 30/10/2017 (Annexure I already circulated).
- RESOLVED that the follow up action taken on the minutes/ decisions of the Sports Executive Board in its meeting held on 30/10/2017 be noted and approved (Annexure – II already circulated).
- 3. **NOTED** and **APPROVED** the action taken by the President Sports Executive Board and Secretary MDUSC in drawing various advances out of MDUSC Funds during 2017-18 for the various purposes (Annexure III already circulated).
- 4. **CONSIDERED** and **AUTHORIZED** the President Sports Executive Board to allow to draw temporary advances in favour of Secretary MDUSC for organizing various North Zone and All India Inter-University tournaments to be held at M.D.U. Campus during the session 2017-18 as per requirement/ need.
- 5. **NOTED** and **APPROVED** the action taken by the President for investing surplus amount of Rs. 5 lakh out of MDUSC Funds in fixed deposit for one year in a bank



through Investment Committee of the University in the name of Secretary MDUSC.

- 6. **CONSIDERED** and **AUTHORIZED** the President Sports Executive Board/ Secretary MDUSC to constitute Organizing Committee/ Sub-committee(s) during the remaining North zone and All India Inter-University tournaments to be held at University Campus during the session 2017-18.
- 7. **CONSIDERED** and after detailed discussion the honorarium to be paid to the officers/ official during various tournaments/ games organized by the University be **ENHANCED** as under with immediate effect:-

- 8. CONSIDERED and APPROVED the proposal that the prize money @ RS. 2100/- each be paid in cash instead of giving it in kind form as already approved by the Sports Executive Board in its meeting held on 11/05/2016 to the officials/ officers of Sports Office who assist in smooth functioning of sports activities throughout the year and the members of Sports Executive Board. A list of such recipients for the session 2016-17 shall be prepared by the Secretary MDUSC for approval of President MDUSC. The expenditure on this account be met out of MDUSC Funds 2017-18.
- 9. CONSIDERED the request of President, Heroes Club, Rohtak for starting a Cricket Academy at MDU Campus. After detailed deliberations the Board RESOLVED that a Committee comprising of the following be constituted to decide the charges/ rates to be charged from the outsiders, Colleges affiliated to the University and also from the University Departments and to decide the



charges/fee to be charged for running Sports Academy at University Campus along with rules and regulations:-

FURTHER RESOLVED that recommendations of the committee be placed before the Patron MDUSC for final approval/ decision in the matter.

- 10. **NOTED** the action taken by the Audit Branch of the University in making adjustment of temporary advances drawn for participation of Indian Universities Badminton (M&W) and Taekwondo (M&W) teams in World University Games 2017 at Taipei along with the refund of balance amount to be sent to the participating students/ official out of advance money/ amount remitted by them. The reimbursement of 50% of expenditure to the student players of MDU shall be made as per decision already taken by the Sports Executive Board in its meeting held on 29/08/2016
- 11. Any other item(s) with the permission of the Chair:
 - a. The Secretary apprised the House that a request dated 16/01/2018 has been received from Dr. Ramesh Sindhu, Athletics Coach for reimbursement of expenditures of Rs. 69227/- for participation in World University Games 2017 held at Taipei as Coach for Indian University Athletics team. The Board CONSIDERED the request and after detailed deliberations it has been **RECOMMENDED** that the reimbursement of expenditure amount be refunded to him out of MDUSC Funds with the approval of Patron MDUSC (Vice-Chancellor).
 - b. The Secretary MDUSC suo-moto has raised/ apprised the house that the sports facilities and playfields/ grounds up to National/ Inter-National level are developed at MDU Campus and requested for revision/ deciding the existing rates to be charged from the various student players/ staff members and outsiders etc. to increase the revenue of MDU Sports Council Funds. The Board CONSIDERED the request made by the Secretary MDUSC and after detailed deliberations it was recommended that the rates/ charges be ENHANCED/ REVISED as under w.e.f. 01/02/2018 subject to the approval of Patron MDUSC:-

Note:

- 1. The above rates/ charges are excluding the use of Gym facilities. The charges for using the Gym facilities shall be Rs. 500/- per head per month for all.
- 2. For the welfare of student players and for development of sports, 10% student players of the total strength of competitive students registered with each coach shall be entitled to have training free of charges on the recommendations of concerned Coach after approval of the Director Sports subject to maximum limit of 10 students for their concerned game. Such facility can be availed by a student player for one game only. However, only one time I-Card fee of Rs. 200/- per session shall be applicable on such students.
- c. The Secretary MDUSC apprised the House that there are seven budgeted sanctioned posts of groundman. Out of seven posts, five groundmen have



already been promoted and remaining two are likely to be promoted to the post of Daftri by the University Authorities and as such seven posts of groundman shall fall vacant and there is dire need for engagement of all the seven groundmen for the maintenance of recently developed playfields/ grounds and also for smooth organization of tournaments/ competitions to be organized by the University as well as for regular sports activities at University Campus. The Board considered the issue and RESOLVED that initially at least five groundmen through outsource agency i.e. approved source be engaged and their wages may be met out of the regular University Budget. FURTHER RESOLVED that the case be sent to the authorities with the request that all the seven vacant budgeted vacant posts of groundmen be filled on regular basis by adopting proper procedure.

d. The Secretary MDUSC apprised the House regarding letter dated 29-12-2017 received from the Deputy Registrar (General Administration) and the action taken by this office for removal of sports canteen. The Secretary MDUSC has further requested that the Sports Canteen may be allowed to run till the completion of remaining North Zone and All India Inter-University tournaments to be held at M.D.U. Campus to avoid any embarrassing situation during the championships and also for the facilities of canteen to the participating teams during the said championships as e-auction for the canteen may take some time. The matter has been discussed in details by the Board and RECOMMENDED that the present sports canteen may be allowed to run by the University Authorities till the completion of tournaments/ championships or a new contractor is engaged through e-auction by the General Branch of the University, whichever is earlier.

Meeting ended with a vote of thanks to the Chair.
