- 4- 6th Round Counselling (Fee Submission upto 09.09.2025) : 08.09.2025

At the time of counselling, the preference for the admission will be given in the following order:-

- i) Firstly, the admission shall be offered to the candidates based on their Academic Merit who have already applied and did not appear in the previous counselling.
- ii) Secondly, the fresh candidates who applied on or upto 01.09.2025 shall be offered admission based on their Academic Merit
