MINUTES OF THE MEETING OF THE PH.D. GRIEVANCE COMMITTEE HELD ON 03.12.2025 AT 2.30 PM IN THE OFFICE OF DEAN ACADEMIC AFFAIRS, M.D. UNIVERSITY, ROHTAK.

The Committee considered the various issues relating to Ph.D. admissions for the session 2025-26 and after deliberating at each agenda item, the Committee made its recommendations as under:

1. Considered the grievances received from UTDs (Psychology, Law, History, Bio-Chemistry) in light of the following decision taken by the Ph.D. Grievance Committee under Reso. No. 3 of its meeting held on 29.11.2025:

"The Committee resolved that the provisional admission of the candidates in Ph.D. Program in UTDs/Institutes/Centres in Counseling-II despite of the fact that their UGC NET Category-II/III was not within one year i.e. validity period as mentioned in the UGC Notification dated 27.03.2024 (Annexure-A) be cancelled and the fees deposited by such candidates be fully refunded by the University. Further, the Head/Director to convey this information to all concerned and do the needful".

THE COMMITTEE RESOLVED THAT THE SAID RESO. NO. 3 TAKEN IN THE MEETING HELD ON 29.11.2025 AS MENTIONED ABOVE IS IN CONSONANCE WITH THE UGC NOTIFICATION DATED 27.03.2024 AND THUS, THE COMMITTEE REITERATED THAT THE SAME BE FOLLOWED BY ALL THE HODS/DIRECTORS OF THE UTDS/INSTITUTES IN LETTER AND SPIRIT.

2. Considered the request of Ms. Sunena & Ms. Ankita for admission to Ph.D. Program in IMSAR who has qualified under Category-II (GEN-EWS) and wished to take admission under Category-III as their score is higher than the General Candidate under Category-III.

THE COMMITTEE RESOLVED THAT PREFERENCE BE GIVEN TO NET CATEGORY-1/2 CANDIDATES OVER CATEGORY-2/3 CANDIDATES ON THE COUNSELLING DATE i.e. 10-12-2025, IN CASE SEATS ARE AVAILABLE ONLY IF THE CUT OFF MARKS FOR NET CATEGORY-1/2 IS HIGHER THAN CATEGORY-2/3. ALL HEADS/DIRECTORS BE COMMUNICATED IN THIS REGARD BY THE ACADEMIC BRANCH WITH EXAMPLE.

3. Considered the complaint received from Ms. Pavitra D/o Sh. Sunder Lal dated 01.12.2025 that an applicant who was not eligible for BC-B category was considered by the Department of Law for admission to Ph.D. Program as his/her latest category certificate (BC-B) was considered while the same was not uploaded by the applicant in online application form.

THE HEAD OF THE DEPARTMENT OF LAW INFORMED THAT THE CASE OF CANDIDATE HIGHER IN MERIT UNDER BC-B CATEGORY AS ALLEGED BY MS. PAVITRA HAS BEEN CANCELLED ON 30.11.2025 DUE TO THE REASON THAT THE CANDIDATE'S NET CERTIFICATE IS NOT HAVING ONE YEAR VALIDITY AS PER UGC NORMS. ACCORDINGLY, THE COMPLAINT STANDS DISPOSED OFF.

4. Considered the requests of the applicants (Law, English, IMSAR) who got admission under Category-II on second counseling on 26.11.2025 and their provisional admissions were cancelled on 30.11.2025 due to expiry of validity of Category-II NET certificates and requested for consideration for admission under Category-III as they have the valid certificate under Category-III.

THE COMMITTEE RESOLVED THAT SINCE THE DATE FOR COUNSELING OF CATEGORY-III STUDENTS WAS ALREADY OVER ON 01.12.2025, THE COUNSELLING ON THE VACANT SEATS, IF ANY, BE CONDUCTED ON 10.12.2025 AS PER SCHEDULE GIVEN IN THE PROSPECTUS AND THE APPLICANTS MAY SUBMIT THEIR UGC NET CATEGORY-III CERTIFICATE TO THE DEPARTMENTS FOR CONSIDERATION IN THE SAID COUNSELLING.

5. Considered the request of Mr. Vikram (UIET) for admission to Ph.D. Program on the basis of GATE Scorecard.

THE COMMITTEE RESOLVED THAT THE REQUEST OF THE CANDIDATE CANNOT BE CONSIDERED AS THE MINIMUM QUALIFICATION FOR ADMISSION TO PH.D PROGRAM IN UIET (ECE) IS THE QUALIFICATION OF ENTRANCE TEST CONDUCTED BY THE UNIVERSITY.

- 6. Any other item with the permission of the Chair.
 - A. Considered the matter with regard to admission against vacant seats created on 30.11.2025 due to cancellation of provisional admission based on NET Certificate not having one year validity as per UGC norms.
