The rules of University Merit Scholarship were amended lastly vide EC Reso. No. 29 of its meeting held on 23.12.2006 (Annexure A/27 pages 415-421). Due to closure of some of programs and introduction of new programs, the existing policy of University Merit Scholarship required modifications.

Minutes of the meeting of the following Committee constituted by the Vice-Chancellor to revisit the existing policy of University Merit Scholarship due to closure of some programmes and introduction of new programmes held on 06.06.2024 at 11:00 am in the office of the Dean Academic Affairs.

The Committee after detailed discussion recommended the following rules for the award of University Merit Scholarship w.e.f. 2024-25 are as under:

Existing	Proposed
<p>The University Merit Scholarship on the basis of entrance examinations may be stopped from the coming session in its present form. However, those students who have already qualified for these scholarships and also have already been offered these shall remain unaffected by this stoppage and they shall continue to get the same throughout the tenure of their course. From the coming session the students of all the professional courses offered by this University through its departments or affiliated and maintained colleges, where entry is at 10+2 level be awarded scholarship on the basis of the results of their first professional examination or semester, as the case may be. The scholarship shall be disbursed from the date of commencement of next semester or class, as applicable. Minimum of one scholarship per course @ one scholarship on every 1000 students thereafter shall be offered @ Rs. 300/- per month during the entire tenure of the remaining course subject to the condition that the candidate secures minimum of 60 percent marks in each University examinations in total.</p>	<p>All regular and full time UG, PG and Five year Integrated programs running under UTDs and in affiliated or maintained colleges/Institutes will be considered for the award of University Merit Scholarship. The Scholarship will be given to one student on every one thousand students and then multiple of 1000 students of that program. However, if number of students is less than 1000 then also scholarship may be given to one student. The scholarship will be awarded on the basis of merit of cumulative result of all the preceding semesters for all programs and the amount of Scholarship would be:</p> <ol style="list-style-type: none">Rs. 500/- per month for UG Programs.Rs. 700/- per month for two-year PG Programs and last 4th & 5th years of Five-year Integrated Programs. <p>The scholarship shall be disbursed from the date of commencement of next semester or class, as applicable. The scholarship will be tenable for the entire tenure of program i.e. upto completion/continuation of program from the Maharshi Dayanand University, Rohtak subject to the condition of that he/she falls in cumulative merit every year. The case of improvement/reappear/ Gap year will not be considered for the merit. A student who earns this scholarship shall not be debarred from applying for fee concession.</p>

Procedure

1. The Registration and Scholarship Branch will arrange Merit List of all the UG, PG and five-year Integrated programs running under UTDs and in affiliated or maintained colleges/Institutes for each program from the concerned result branches consisting of total number of candidates appeared for each program to finalize the numbers and name of the candidates for the award of University Merit Scholarship.
2. The concerned College will submit the claim bill for the release of payment as per format prescribed by the Registration & Scholarship Branch (Annexure-1)
3. The Scholarship shall be awarded on approval by the Vice-Chancellor annually.
